Admiral Security, using radar and observing general road rules has made a difference on our roads! If you have guests please remind them of speed limits and stop signs. The member is always responsible for any violations a guest might incur. Remember the speed limit at BRS is 25 MPH, in some cases 15 MPH. The fine is \$50 per offense.

BRS now allows golf cart usage on our roads. You will need to drive your cart to the office to obtain a decal and rules. Your cart MUST have a decal to be operated. Your golf cart must have proof of liability insurance. It must be insured as a golf cart and must have a serial number on the insurance certificate. ONLY GOLF CARTS qualify. No gators or other ATV's allowed. To operate you must have a valid driver's license. Under age driving is strictly prohibited and may result in the loss of the owner's cart privileges. We have asked Denny and Compliance to be very strict on any violations. I am also asking members to report any violations they might see. You will need an annual decal.

Please stop by the office and fill out a Recorded Restrictions form. This needs to be done every 10 years as a requirement by the county. You may also request a form. When received simply sign in front of a notary at your bank and mail in, or drop off at the BRS office. If your deed is in more than one name the majority must sign and notarize. Amy and Jessica are both notaries. This must be done; please make every effort to get yours done soon.

We on the board would like all of our members to be correctly informed, and active in our community. If you have concerns or questions the board meets every 2nd Saturday of every month, except December, at 9am. All are more than welcome. You can also volunteer on our various committees to keep you involved in the community, and its processes. We are always looking for folks to chair events. Every committee, every chairperson, every board member are all volunteers. Every activity is manned by volunteers. Thank you to all. BRS could not function without our volunteers! If you know one, thank them.

SECTION III

Policies, Rules, and Regulations

F. Lake:

1. No barrels, buoys, floating docks, etc. of any kind shall be placed in the Lake without prior written approval of the Board. Using a Lake Request Form, state object, its purpose, placement locations, distance from shore and justification for policy exception. The Form will be reviewed and approved by the General Manager for accuracy and forwarded to the Board of Directors for final review and approval.

a) The Board reserves the right to deny requests, move, remove, or adjust the location of any or all non-permanent structures placed in the lake.

b) Control buoys together with necessary concrete, anchors, chains, etc., shall be provided by the Association.

c) All unapproved items will be removed immediately, at the expense of the member, as directed by the General Manager.

d) Inflatable temporary devices or play items must be anchored or tethered to the dock or shoreline in such a manner that prohibits them from floating away. They can protrude out into the Lake no more than fifty feet (50') from the shoreline.

Attention Blue Ridge Shores Property Owners Recorded Restrictions Committee

The BRPOA Legal Documents & State Law requires the Association to renew its Restrictive Covenants every ten years. These covenants provide for the maintenance and expansion of the infrastructure of Blue Ridge Shores. The existing covenants are set to expire on January 1, 2020.

Please sign, notarize and return the affidavit to the BRS office. Signatures must match the current deed on record. If the property is owned jointly by two or more people, a majority of ownership must sign the form. If there are two owners on the deed, both must sign. Signatures must be notarized and can be done at most banks, law offices, libraries, and at the BRPOA office.

RECORDED RESTRICTIONS

The following restrictive covenants and conditions shall be applicable to and binding upon those certain lots and parcels of land shown on a certain plat or plats of Blue Ridge Shores Subdivision, filed or to be filed for record in the Clerk's Office of the Circuit Court of Louisa County.

1. Said lots shall be used exclusively for residential purposes except those lots designated as business or commercial areas on the maps or plats aforesaid.

2. Not more than one single-family dwelling house may be erected on any such residential lot, or more than one other building for garage or storage purposes in connection therewith and provided further than such garage or storage building shall not be constructed prior to the dwelling house. No accessory or temporary building shall be used or occupied as living quarters. No building shall be constructed or erected on said lot unless built of solid or permanent material. Wood exteriors shall be stained or painted with at least 2 coats of stain or paint. No structure shall have tar paper, roll brick siding or similar material on the outside wall. No trailers, tents, shacks or other structure shall at any time be occupied as a residence on said property and no trailer designed for living purposes shall at any time be brought upon or store upon said property.

3. No residence of less than 600 square feet of living space, exclusive of the porch area, shall be erected or constructed on said lots. Plans for buildings to be constructed or erected on said lots shall be subject to approval of Blue Ridge Shores, Inc., or its assigns, before construction is started.

4. No porch or projection to any residence or appurtenant building thereto shall extend nearer than 20 feet from the front line of the property or within 8 feet from the line of any abutting owner, except where set-back lines appear on the plat, structures or appurtenant buildings thereto may be constructed within the described areas shown by such lines.

5. No outside toilets shall be allowed on said lots. No waste shall be permitted to enter Lake Louisa and all sanitary arrangements must be inspected and approved by local or state health officials before any septic tanks are installed or before waste disposal systems shall be constructed. No drain field or other disposal system shall be allowed nearer than 50 feet from the high water mark of Louisa County.

6. No animals or fowl shall be kept or maintained on said lots except customary household pets. No signs of any kind shall be displayed on any lot without the written permission of Blue Ridge Shores, Inc., or its successors and/or assigns.

7. Blue Ridge Shores, Inc., for itself, its successors, assigns and licenses reserves easements, as shown on said plats, over, through and upon said land for the installation of utilities and drains and the maintenance thereof. Blue Ridge Shores, Inc., for itself, its successors, assigns and licensees also reserves the right to install and operate electric and telephone lines, poles and appurtenances thereto; gas and water mains and appurtenances

thereto; sewer lines, culverts and drainage ditches, reserving also the rights of ingress and egress to such areas for the purpose of installing, operating and maintaining any of the above mentioned installations. Blue Ridge Shores, Inc., for itself, its successors, assigns, and licensees also reserves the right to locate and install drains where it deems necessary and to cause or permit drainage of surface waters over and/or through said land. The owners of said land shall have no cause of action against Blue Ridge Shores, Inc., its successors, assigns or licensees either at law or in equity, excepting in cases of willful negligence by reason of any damages caused said land in installing, operating and maintaining above mention installations.

8. No boat docks, floats or other structures extending into the lake shall be constructed or placed into or on said lake without prior written approval of Blue Ridge Shores, Inc., its successors and/or assigns. No loud or annoying motors shall be permitted on the lake between the hours of 10:00 PM and 8:00 AM.

9. No noxious or offensive trade or activity shall be carried on any lot, nor shall anything be done thereon which shall be or become an annoyance or nuisance to the neighborhood.

10. These restrictions shall be considered as covenants running with the land and shall bind the purchasers of all lots shown on the subdivision map or maps hereinbefore referred to, recorded or to be recorded, their heirs, executors, administrators and assigns, and if said owners, or any of them, their heirs, executors, successors or assigns shall violate or attempt to violate any of the covenants or restrictions herein contained, it shall be lawful for any person or persons owning any such lots in the subdivision in which said lot is situated to prosecute any proceeding at law or in equity against the person or persons violating or attempting to violate any such covenants or restrictions and either to prevent him or them from so doing, or to recover damages for such violation. Any invalidation of any one of these covenants and restrictions shall in no way affect any other of the provisions thereof which shall thereafter remain in full force and effect.

11. Restriction No 1. Contained herein shall continue for a period of 99 years from the date of the recordation of these restrictions in the Clerk's Office of the Circuit Court of Louisa County, Virginia.

12. All of the restrictions, conditions, covenants and agreements contained herein, other than restriction No. 1 herein, shall continue until January 1, 1970, and may as then in force, be extended from that date for a period of ten years without limitation by the assent, evidenced by appropriate agreement entitled to record, of the owners of two-thirds in area of the property described in said deed, exclusive of streets, private lanes and parks, private or otherwise.

The foregoing restrictions were recorded in the office of the Clerk of the Circuit Court of Louisa County, in Deed Book 106, Page 416, on April 1960.

(Note: the necessary agreement was recorded to extend these restrictions until January 1, 2020.)

BOARD MEMBERS PRESENT: Alex MacCormack, William Munday, Bill Haase, Al Fortune, & Steve Burrill. Board Member Molli Ellis & Stephen Tompkins were absent. Denny W. Kelly, GM and Amy Evans-Kail, Manager of Fiscal Affairs were also in attendance.

MOTION: Al Fortune made a motion, seconded by William Munday to approve the agenda as presented. The motion carried unanimously.

MOTION: Steve Burrill made a motion, seconded by William Haase to approve the May 4, 2019 minutes as presented. The motion carried unanimously.

MOTION: Steve Burrill made a motion, seconded by William Munday to approve the May 18, 2019 minutes as presented. The motion carried unanimously.

MOTION: William Munday made a motion, seconded by Al Fortune to accept the May 2019 and June 2019 Treasurer's Reports as presented. The motion carried unanimously.

MOTION: William Munday made a motion, seconded by Steve Burrill to approve the revised Records Retention Policy dated 7/2/2019. The motion carried unanimously.

MOTION: Al Fortune made a motion, seconded by Steve Burrill to accept the Mid-Atlantic proposal for refurbishment of the Redbud Storage Tank dated 4/22/2019, options 1, 2, 3, 4, 5, 6, 7. Total \$19,532.00 to be paid for out of replacement reserves. The motion carried unanimously.

MOTION: William Munday made a motion, seconded by Al Fortune to accept Atlantic Pumps proposal for temporary water supply tank for the storage tank refurbishment including necessary piping and valves for a total of \$34,500. The motion carried unanimously.

MOTION: Al Fortune made a motion, seconded by William Haase to adjourn the meeting. The motion carried unanimously.

Revision to ByLaws, Article IV, Section 2, Guests

A gentle reminder of revisions to the Guest Policy as approved by the Board of Directors during their August and September, 2017 meetings and the two bold sentences contain those revisions:

Section 2. Guests: Each Member or Non Member Occupant shall have the right to extend guest privileges, but, subject to such regulations as may be adopted by the Board. Members and Non Member Occupants are at all times responsible and will be held accountable for their actions of their guests. Guest actions may result in complaints submitted to the General Manager, Compliance Committee, or Board of Directors potentially resulting in the member incurring a fee or a loss of privileges. Any individual who gains access to Blue Ridge Shores via the member access in any manner shall be considered the Member's guest. Any member or Non Member Occupant extending guest privileges will either accompany their guests to the common area being used or send an email to the office with the guest's name, number of people with them and type of vehicle being driven. Visitors not accompanied or identified by email will be asked to leave by the General Manger or his/her designee.

Water Usage in the Summer Months

The 3rd qtr. of the year, mid-June through mid-September, is typically the highest water usage quarter of the year for our members. Please be mindful that excessive watering of your lawn, irrigation systems, filling pools, extra house guests, etc. all add to increased water usage during the summer months, which will be reflected on your 3rd qtr. water bill.

METER BOXES

As a reminder meter boxes are the property of Ridge Utilities, Inc. Customers are not permitted to park vehicles, place lawn ornaments, plant shrubbery, flowers, etc. on the meter boxes. Any items placed on top of the meter box will be removed by Ridge Utilities, Inc. personnel without notification to the customer. Meter boxes must be accessible to Ridge Utilities, Inc. personnel at all times.

2018 Annual Water Quality Report

Water Conservation Tips with Big Impacts

We've all heard shut off the water while brushing your teeth or turn off the faucet while washing dishes. These tiny changes are effective and, believe it or not, the savings are significant. Imagine this: 90 glasses of water per day are saved by a single turning off the tap. That's a total of 27 billion glasses of water every day if everyone chipped in.

Check your pipes for leaks, not only do leaks damage your home, but they're a sneaky source of wasted water. Make sure when you are watering your lawns they are landscaped for effective water usage. Make sure sprinklers are placed in a way which maximizes efficiency. Don't run you washing machine or dishwasher unless they're full.

DRIVING TIPS

1. Do not text and drive - Statistics show that if you are communicating by text while driving a vehicle, you are 23 times more likely to crash.
2. Be sure before you pass - It's not safe to pass a bicyclist going downhill, around curves, or when he is riding his bike at the same speed as traffic. Make sure there is enough room to safely pass, and you can gauge the bicyclist's direction. Do not cut off the bicyclist when turning right. When you pass, make sure it's slow and careful.
3. Acknowledge bicyclists and walkers with eye contact or a wave - This shows that you see them and are paying attention to his/her direction and intention.
4. Give them room - At least three feet of clearance gives bicyclists and walkers room and prevents accidents.
5. Don't honk your horn - Honking your horn can startle a bicyclist and send him veering off the road.

We appreciate the many members and guests that have been considerate of others during your visits to the beach this year. Rules of the Beach are posted and we respectfully submit they apply to everyone. Ridge Utilities furnishes water for the bathrooms and outside faucets without charges, so please be considerate and do not let children play in the streams or leave them on once you have cleaned the sand off your feet.

The 2019 Asphalt Rehabilitation Program will start within the next month and will produce some traffic delays and we promise to minimize those to the best of our ability. You will be notified by mass email of those areas impacted as soon as the schedule with Barton & Boyd is established.

I urge those that wish to sign up for a partial payment agreement in order to avoid higher monthly payments, **should do that immediately.** To date we have approved thirty eight and five of those have paid in full. **We have collected 91% of the 2019 revenue affiliated with assessments and rental fees by the end of June, 2019.** A MNIGS Hearing was conducted on July 13, 2019 where 41 Members were declared to be MNIGS. Our delinquency rate for 2018 was 2.0%.

Please check your 911 address for your property and be sure it is accurate and per the regulations. The 911 address as assigned by the County must be displayed in three inch numbers, clearly visibly from the street. That address/number must be displayed on the side of the street that the house is located and be adjacent to the entryway/access to your house from the street. This is very crucial when seconds count in having emergency personnel responding to your needs.

The Association is currently using Admiral Security Services to monitor speeds on the Streets in the Community in order to curb vehicle speeds. We respectfully ask all to work with us on this program and report any issues you may have.

Ridge Utilities is very pleased to announce that all wells are in excellent condition for water supply and all required testing to date has been completed with a 100% passing of those requirements. The 2018 Water Quality Report was distributed early and if you did not receive that, extra copies are in the office.

The Ridge Utilities Board of Directors approved a \$54,032.00 project to refurbish the Redbud Water tank during the Spring of 2020.

We regret the inconvenience & concerns that the recent Green Sheen from the Algae Bloom has created for you. This appeared just before the July 4th celebration resulting in the temporary closing of the Main & West Beaches during the same period. Lake waters have been tested for E-Coli on a weekly basis through the lab in Culpeper and the most recent one to date, July 17, 2019 continued to improve. WE will test again on July 30, 2019 and keep you posted. Water Quality Testing of the Lake normally occurs monthly from May through September.

Please remember when you are the lake enjoying boating to maintain a safe distance of 100 feet off the Shoreline and if you are pulling floats or tubes, need to have that spotter. Failure to do that could result in the Compliance Committee suspending your recreational privileges for a period of time. Please respect members' docks, boathouses, and seawalls by maintaining that distance away. Please contact the office with any witnessed violations and BRS decal numbers if possible.

Should you witness any activity that appears unlawful contact the Sheriff's Department immediately and also make the office aware of the issue including tag numbers, type of vehicle, and if by chance you know the individual(s). Your identity will not be disclosed by them. If you experience an event that is not neighborhood friendly, please contact the Sheriff Office immediately. Their non-emergency # is 967-1234.

WALKING AND SAFETY

Walking is a healthy activity, but you need to know the rules of thumb of pedestrian safety. This is especially true if you are walking in BRS where there aren't sidewalks or paths separate from the road. To stay safe walking, follow these rules of the road:

1. Walk Facing Traffic When Walking on the Side of the Road

This gives you the best chance to see traffic approaching closest to you and take evasive action when needed. This may be confusing because the opposite rule is true for cyclists, who cycle in the same direction as the traffic flow.

2. Cross Safely

You should look both ways before crossing any street. Make eye contact with any drivers who may be turning. Give them a wave to make sure they see you.

3. Walk Single File When Not Separated From the Road

This is especially important on BRS roads that have lots of curves and where traffic has only a split second chance of seeing you before hitting you.

4. Stay Aware of Bikes and Runners

Share the road and path with bikes and runners. Bike riders should alert you when approaching from behind with a bike bell or a "passing on the left/right." Listen for them, and move to walk single file, allowing them to pass safely. Runners should also call out for passing. Bike-walker collisions can result in broken bones or head injury for either—and you aren't wearing a helmet.

5. Be Visible

Wear bright colors when walking in the daytime. When walking at night, wear light-colored clothing and [reflective clothing or a reflective vest](#) to be visible.

6. Keep the Volume Down

Don't drown out your environment when listening to music with your earbuds or headphones. Keep the volume at a level where you can still hear bike bells and warnings from other walkers and runners. Your audiologist will also thank you.

7. Hang Up and Eyes Up

[Distracted walking](#) due to chatting, texting, or playing games on a mobile device while you walk is as dangerous as doing those things while driving. You are distracted and not as aware of your environment.

8. Walk Dogs on Short Leashes

When walking your dog on a long leash there is a danger that you will trip other walkers or bikers. Keep your dog safe as well as those around you by using proper leash walking etiquette.

9. Know When to Stop Walking

[Heat sickness](#), [dehydration](#), [heart attack](#), or [stroke](#) can strike walkers of any age. Learn the symptoms of medical emergencies and carry a cell phone to dial 911. Even if you are a seasoned and well-trained walker, you may experience one of these problems and need to cut your walk short.

LET'S BE PROACTIVE ABOUT THE SPREAD OF HYDRILLA

Many of you will remember that around 25 years ago, Lake Louisa had much of a type of grass called hydrilla. This is an invasive aquatic plant originally imported into the U.S. to be used in aquariums and sometimes called "water kudzu" because it grows so fast. Hydrilla became so thick in the lake that many of the coves were unsuitable for swimming or wading and it even became difficult to operate boats in these areas because the hydrilla fouled the propellers so badly. By introducing a type of grass carp that feeds on hydrilla and other underwater vegetation (not the common carp found in most rivers, lakes and ponds) hydrilla has been eliminated from the lake. Hydrilla was also a problem at Lake Anna and was similarly controlled by using grass carp.

While we have not seen any evidence that hydrilla is making a comeback in Lake Louisa, it is definitely making a comeback in Lake Anna and other rivers and lakes in Virginia. We do not want to have a recurrence in our lake. **Hydrilla is easily spread by introducing even very small pieces into the water. Therefore, everyone that uses their boats in other lakes or rivers is strongly encouraged to carefully check the boat, motor, propeller, and trailer and thoroughly rinse them off before launching in Lake Louisa. Do not allow the runoff from this enter the lake.** Much more information can be found by doing a simple internet search on "hydrilla in Virginia waters". Your cooperation will help protect the health of our lake.

2019 Boating Policies and Safety Tips

Boating Season is here, and we hope everyone has a 2019 Fun but Safe experience. Blue Ridge Shores adopted the provisions of the **Virginia Boating Safety Education Requirement** for operation of a motorized boat on Lake Louisa. The Virginia Conservation Police Department has authority to enforce all provisions of State Requirements on Lake Louisa. Just a few reminders for everyone:

- Anyone operating a motorized boat in Virginia must possess a card indicating they have taken the **Virginia Boater Safety Education Class** or the State's Safety Class where the boat is registered.
- Operators must be at least 14 years old.
- Boats must be registered to a member or a non-member occupant who are members in good standing.
- All motorized boats must be registered through the office with current State Registration and Insurance Information in order to have and display a current Association Decal.
- All Non-Motorized Boats excluding a paddle board must be registered through the Association and display the appropriate decal.
- Jet Skis and jet powered boats are not permitted to be on the lake. Jet powered boats registered with the Association prior to August 13, 2011 are exempted from this rule.
- All motorized boat traffic must travel in a counter clockwise direction, unless they are fishing and under the power of a trolling motor.
- All boats that are non-motorized have the right of way.
- **All fast moving boats are required to stay off the Shoreline by 100 feet.**
- All boats pulling tubes, skis, aqua boards or any other object are required to have a spotter. These activities are limited from 9:00 AM until sunset.
- All boats are to have running lights or navigational lights after dusk or before dawn.
- The Association's Special Assistant to the GM is patrolling the Lake and will issue violations as appropriate and the member affected will be required to attend a Compliance Committee Hearing.

Should you have questions, require clarification, or a copy of these rules, please contact the office.

Boat Registration

Please register your boats with the Office to avoid problems on the lake when you wish to enjoy that privilege. We can register your boats via mail for your convenience. As a reminder, the office will need **CURRENT** copies of your State registration, Insurance Policy that shows watercraft liability, and Boaters Safety Class record. If you renewed either of these since your previous registration with the office last year, please make sure to forward a copy to the office. Should you wish to verify if we have current information, please call the office. You must have paid the first half of 2019 assessments to acquire decals.
