#### **Dogs Eligible to Enter**

This trial is open to all dogs 15 months of age or older that are registered with the American Kennel Club or are register-able breeds that have obtained PAL/ILP numbers from the American Kennel Club, except bitches in season, aggressive dogs, blind dogs, or dogs suffering from any deformity, injury or illness which may affect the dog's physical or mental performance. **Mixed breed dogs** listed in the AKC Canine Partners program are eligible to enter this all-breed AKC agility trial. Mixed breed dogs entered in these events must list the breed name as "Canine Partner" (mixed breed) and not as a breed hybrid and must include their AKC Canine Partners number on the entry form and check the AKC No. Box.

#### Information

We will also be awarding High in Trial Special Rosette Ribbons, for runs on Saturday only, to the highest combined score from two clean rounds, for all dogs entered in the show, in the regular classes for each of the AKC Recognized Breed Groups (Sporting, Hound, Working, Terrier, Toy, Non-Sporting, Herding and Miscellaneous) plus a Canine Partner group. Scores of 100 in both classes is required to be in contention. Scoring is based on the highest combined YPS.
