Minutes of June 21, 2021

The Huntington Township Trustees met in special scheduled public hearing at 6:45 PM at the Township Hall. Meeting called to order with the pledge of Allegiance by Robert Holmes. Also present were Walter Rollin, Jed Lamb, Dennis Finkel, Matt Combs, Carl Strekely, Amy Papuga, Robert Papuga, Frances Rollin, Deputy Joe Sprouse and Sheila Lanning.

Robert Holmes read the purpose of the Public Hearing was to review a proposed Land Use Plan. Holmes read the entire Land Use Plan aloud. Asking for questions from the public and hearing none the Public Hearing adjourned on a *Motion* by Lamb with a second by Rollin at 7:01 PM.

The Huntington Township Trustees opened their regular scheduled meeting at 7:02 PM.

Motion by Lamb with a second by Holmes to approve the minutes of the regular scheduled June 7, 2021 meeting as written. Roll call: three yeas. Checks 9550 – 9565 and payments totaling \$24,884.73 approved for payment.

Motion by Lamb with a second by Rollin authorize *Resolution 2021-40* approving the Township's Land Use Plan as presented in the previous Public Hearing. Roll call: three yeas. Rollin expressed thank you to all the people who worked to put together the Land Use Plan and especially Lyn Ickes.

COMMITTEE REPORTS:

WATER BOARD- Lamb: Meeting in person again, the lobby is open, getting back to normal. Parts are expensive, need upgrade to the main transmission line, looking at options.

LORCO- Lamb: doing fine, nothing ground breaking.

AMBULANCE- Holmes: Re-grouping, trouble getting staffing. Year to date 733 runs with 45 in Huntington. May had total of 5 Huntington satellite location runs. 2020 had 687 runs at this time last year. One staff will meet Trump at airport and ride in the motorcade with the upcoming Trump rally, the group will be on call.

SHERIFF- Deputy Sprouse: told to expect 15,000 to 20,000 people- and 40 secret service. All Sherriff deputies on duty. All surrounding police departments are assisting.

FIRE- Rollin: Going well, everything in place, no further word on the open house. Ladder truck down for repair, costing about \$17,000.00 to fix.

OPWC- nothing

SWAC- Finkel: Talked to Romancak and may not need an MOU for the mini grant.

ZONING BUSINESS/NEWS- Lanning: Trustees need to review the Conservation District Zoning. The Zoning Appeals Board authorized a Variance request and a conditional permit.

THRIVE & OFFICE ON AGING- Rollin: Thrive received a Community Health Investment Grant. **CEMETERY-** Lanning: call from Mr. Prante asking about lot for wife Debbie Kelsey Prante. Wilbur Kelsey transferred lot 102 West to daughter Debbie Prante. No payment received for foundation from Dennis Dawson. Finkel: he contacted Mr. Dawson and a check will be dropped off.

ROADS and EQUIPMENT: Finkel: Blacktop put on roads in preparation for Chip and Seal. Looking at the 24th to start the work. They delivered new mower, put down 120 tons up North. Not sure on what is left to patch. Majority of patching done. Status of old Gradall up and running. New one not totally fixed because it can wait till a rainy day. Not ordered the seal kit for new Gradall yet, expect it to cost \$1,400.00. Roller and trucks are in good shape this year so far.
