## <u>Highway Superintendent Report:</u>

Working on Mitigation plan, keeping track of hours. Met with Spectrum, they are placing – burying cable (fiber optic) setting poles on ditch side. Met with crew and checked with Town Attorney, checking to see if we have road agreements.

We have been plowing, sanding and working on the trucks. An engine light in 205 and 206. In 206 it was a transmission sensor, the turbo was faulty. We had an oil pan rotted out and a pan on transmission rotted through. We have been cold patching in Town. 205 and 206 brakes and spring checked. Started chipping Standish road and by the 4-H Camp. Letters sent to residents regarding this issue of chipping. Centerline moved again, Al Fagan they want their engineers to check on this site. They have some funds to help us with.

Supervisor May discussed that Verizon is looking to check with our residents regarding their cell service, or lack of. We will place information on website for residents to respond to the question.

<u>Town Clerk Report:</u> Our Town website visits for February 2020 were 2075. The Towns total revenue for the month of February 2020 was \$204.00, \$189.00 for dog licenses, \$15.00 for dog late fees. We had 15 dog renewal licenses and 3 new licenses. To the general fund, \$68.00, Dogs were \$53.00, \$15.00 late fee. We disbursed \$110.00 to Wyoming County, \$26.00 to Ag and Markets for dogs. The link information on our website regarding Spectrum, is still not currently working.
