

LBSRC 'PHASE III' POLICIES (6 25 2020)

In accordance with the Governor's guidelines for Phase Three for outdoor swimming pools, the following mandatory policies and procedures will be in effect for Long Branch Swim & Racquet Club, effective Wednesday, July 1, 2020 and continuing until further notice:

1. No more than 100 patrons, members and guests will be permitted inside the facility at a time.

2. Reservations for general pool access via Sign-up Genius are **REQUIRED**. Members may sign up for a maximum of <u>three</u> hours per day (which may be consecutive or non-consecutive).

3. Prior to entry into the facility, all members must self-certify that:

a. They are NOT currently experiencing fever (100.4 degrees Fahrenheit or higher) or a sense of having a fever.

b. They are NOT currently experiencing a new cough that cannot be attributed to another health condition.

c. They are NOT currently experiencing new shortness of breath that cannot be attributed to another health condition.

d. They are NOT currently experiencing new chills that cannot be attributed to another health condition.

e. They are NOT currently experiencing a new sore throat that cannot be attributed to another health condition.

f. They are NOT currently experiencing new muscle aches that cannot be attributed to another health condition or specific activity (such as physical exercise).

Anyone experiencing any of the symptoms above WILL NOT be permitted in the facility.

4. Free swim is permitted.

5. Lap lanes 5 & 6 will be maintained for lap swimming only. Reservations (using SignUp Genius) for lap swimming will be available but are not mandatory. Members

may reserve a lap lane for 30 minute increments, up to a maximum of 1 hour per day. Lap lanes will be limited to 2 swimmers at a time.

6. The baby pool will remain closed.

7. Swim instruction is permitted. Instructors may have contact with swimmers when necessary.

8. All patrons (except those from the same household) must remain 10 feet apart during all activities, including while in the pool.

9. The deck will be managed as follows:

a. Tables will be set up 10' apart. Please do not move the tables.

b. Lounge chairs and deck chairs will be set up in pairs 10 feet away from other chairs. The pairs can only be used either by two people in the same family unit or by an individual. Pairs of lounge chairs can be moved closer together to accommodate family units. If you move furniture, please move it back after use.

c. All deck furniture MUST be cleaned and disinfected between use. Disinfectant will be available at the check in desk. You are required to clean and disinfect all deck furniture before and after use. This is the job of the members, not the lifeguards.

d. "High touch" surfaces such as faucets, toilets, doorknobs, and light switches within the pool area will be cleaned by the lifeguards in accordance with CDC guidelines.

e. When social distancing of 6 feet or more on the pool deck is unable to be maintained, members are encouraged to wear face coverings that fully cover the nose and mouth area. That includes during the check-in process.
