She presented:

- --First Half Taxes have been received and deposited she gave each member a print out.

- --Thomas reported that gas taxes are not coming in as high as he thought they would. He projected that the Township will only receive about 80% of the budget if it continues to go along the same pattern as the first quarter. He cautioned the members.

Dale Novak told the Federal EPA representative that none of the local political subdivisions would ever qualify because they don't put that many miles on their trucks each year. The EPA representative said they might do something later on.
