Reflections on understanding a living and vital faith

In Mark 12:28 Jesus is asked by a scribe: "Which commandment is first of all?" Jesus responded with "the Lord is one," and went on to say, "You shall love the Lord your God with all your heart, and with all your soul, and with all your mind, and with all your strength" (Mark 12:30). These words are very similar to those that served as Israel's central confession of faith (Deuteronomy 6:4-5).

Joshua (22:5) later reminded the people of Israel to observe these words. With this text as a guide, how do we begin to explore the ways we will nurture a living and vital faith in each person and the congregation?

Within the work of the Evangelical Lutheran Church in America, congregational vitality is defined as "communities of Jesus where there are life-changing relationships with God, one another and the world." These are three important dimensions of our work together. But it is the way in which we bring our heart, soul, mind and strength into our life and work that shows how the light of Christ shines in and through us. Our heart is the way we feel and sense God's presence in and through emotions. The soul is our mindful awareness of the presence of God within us and the world. This awareness encourages us to find meaning and purpose in life, both individually and as a community of faith. The mind is how we learn our beliefs, perspectives and practices that shape our understanding, knowledge and expressions of faith. And strength is the way we use our abilities, passions and skills to shape and live a life of faith.

The vitality of our faith as Christians, and as a church in the Lutheran tradition, finds meaning and purpose in Jesus' words from Mark 12:30. As we engage our strategic directions for the future, we find both power and insight by reflecting on what brings us vitality. Please consider the following:

Heart

- When are the times you feel or sense God is present?
- How are these experiences different when you are with others rather than alone?
- How do these emotions bring vitality to your faith and relationship with God?

Soul

- What Scripture passages give you an awareness of life or "living faith"?
- How does this awareness of a living faith help you find meaning and purpose in life?
- What about your life experiences brings a sense of vitality to your faith?

Mind

- What motivates you to continue growing in your relationship with God?
- What have you found helps you learn more about God?
- · Where do you find vitality through your learnings and spiritual practices?

Strengths

- What God-given abilities, passions and skills have you discovered in your life?
- How does your faith guide you in using these?
- What about using these abilities, passions and gifts gives you vitality?

May your responses to these questions help you gain new insight and vitality into your relationship with God, each other and the world.

Sandra Anderson is going off Council and as being secretary. Arlene thanked Sandra.

Report of Pastor: Pastor Rinas spoke about the last year's being a lot of fun with celebrating the 500th anniversary of the Lutheran Reformation and the 150th anniversary of our church. There were events held throughout the year providing opportunities for us all to get together. This coming year the congregation faces some hurdles. We live in a society that is becoming less religious and less interested in participating in the church. How we continue to relate to and engage in the community and work with people is difficult to figure out. However, Pastor Rinas has proposed some changes to his focus and work that will move our model from a traditional model of the church to an engagement model. He feels this is a move that could bring about some good results and could be a way of changing the congregation's focus and of gathering together. He looks forward to implementing that in the new year. The goals are at the bottom of his report. Dawne thanked Pastor Rinas for providing his goals for 2018. Not in the written report is that we are facing difficulty with our budget. We have to look at the balance of funds we're spending on our property. The question is how this fits into our mission and model of ministry as a percentage of our funds goes to property as opposed to other things. Pastor Rinas sees ways of helping reduce cost, by having some individuals being involved in cleaning and maintenance to help reduce cost. He thanked those who have been helping with office work folding bulletins. In the future, this may be something we want to continue.

There are areas where we can participate to help control cost. Pastor is posting the administrative position. Pastor has been doing the administrative work until we hire a new parish administrator.

Pastor Rinas thanked Kim for the unbelievable amount of work and countless hours she has spent on the fair this year and every year. The committee would like to have the funds dispersed - \$1,500 to the External Scholarship, \$500 to Covenant to Care, \$500 to the Community Garden expenses, \$1,000 to Bread for Life and \$500 for the Southington Community Services.

2018 Pastor's Report, February 2019

Bishop Hazelwood has emphasized in his communication with New England Synod congregations, "the definition of insanity is doing the same thing over and over again while expecting different results." He is, of course responding to what he has seen in many congregations—the hope, or longing, for different—more positive outcomes, while retaining the same practices, customs, styles, programs, culture.

This has again been a year of experimentation at First Lutheran.

Chill Sundays. With always decreased participation during the summer months, including attendance in Sunday morning worship, we tried a different pattern and venue in June, July, and August. First's sanctuary gets very warm in the summer sun; have you noticed how our new paschal candle bent while standing near the lectern?

We tried to create a chiller environment for worship – with a lower temperature, cool coffee, and less formality. We moved in air conditioners to cool the space, I made cold, iced coffee, and we worshiped in the Parish Hall, with chairs surrounding a central table, font, and podiums.

Some thought being outside our sanctuary meant this just didn't feel like worship. However, feedback was largely positive, appreciating the beauty of the central worship space, underlined with an oriental rug, but most of all, the intimacy of the smaller space bringing worshippers into closer contact.

Administration. This was a strenuous year. It began with a sixth month period where we were without a Parish Administrator after the resignation of Rachel Love. Due to the high level of activity we had in the congregation during those months, with our hosting Southington's Interfaith Thanksgiving service as well as the 4 parish collaborative Blue Christmas service, along with Advent, Christmas, the Annual Meeting, and an early Lent and Holy Week, this was an exhausting double responsibility. Only after this did I have the time to work on searching for and hiring a new administrator. The silver living was that my taking over that work saved us over \$5,000.

We were pleased to find Carol Keough to sit in the administrative chair. We chose her from among 42 applicants, and after many interviews. I had hoped this would bring an end to the difficulties. Unfortunately, we faced a substantial learning curve as well as confounding changes with Microsoft Software (Office 365, Windows 10, OneDrive). Adoption has been crazy-making for both Carol and me. The number of times I have had to redo bulletins or other documents are countless. On the positive side, we have learned a great deal and continue to develop protocols to improve our work.

I am very grateful to have the support and guidance of Joe Novak, who played an indispensable role as an advisor throughout upgrading the office computer and software.

Membership Records. Toward the end of 2018, we took on the task of comprehensively updating membership records. This is a sprawling project, of which we are well underway, but much work behind the scenes remains. We hope all of this will result in a text-based directory in upcoming weeks and a pictorial directory in upcoming months. This will assist in all aspects and dynamics of our congregational life.

Improving the accuracy and fullness of this database will also open further possibilities for its use. Should the congregation choose, we would be able to create a secure, password-protected, online directory for members that would be updated every week. We would even have the capability of adding a mobile app for even easier access.

Declining Participation. The Church is in a time of upheaval/change/re-birth not seen in at least the past 500 years. You will notice that we had an average Sunday attendance this year of 59, down from 61.59 last year. It can be discouraging to see these numerical declines. Yet, we are in an era where the church in North America is in numerical decline (—and has been for decades, though nothing like the falloff in the past three years). And within the U.S., the Northeast, within mainline churches, within Southington, First Lutheran continues to fair better than the vast majority. This is not to take solace that we aren't declining as fast as others, but rather to acknowledge our context.

I am grateful for the relationships in this congregation—and for new relationships that continue to reveal themselves. I find joy in the growth of relationships—sometimes foreseen and at other times unexpected—that continues with abundance and are only sometimes reflected in numerical accounts.

Making Christ Known. I am grateful for the work of so many who work hard so that Christ may be known through our work and witness. I am grateful for the careful and precise work of the Finance Committee to steward and manage the monetary assets of the congregation. I am grateful for the Women's Guild's tenacity and care for First Lutheran. I am grateful for Paul Brann and the Property Committee who do so much investigation and labor for the upkeep of the property gathered and built in previous generations. I am grateful for the expertise and conscientiousness of the Parish Life committee in planning and supporting events that create community through fellowship. I am grateful for the planning and oversight of the Worship & Music committee tending to our worship life as a congregation and for Tyler Boyle's skill enriching it. I am grateful especially for the incredible commitment Kim and Keith Gray make and all those who continue to work to create the amazing Holiday Fair. I am grateful for the Scholarship committee's diligent work to recognize and support the education and growth of our younger generation. I am grateful for the Christian Education Committee's dedication to sharing the Gospel with and caring for these young people too. I am grateful for the Covenant to Care team who help us all get involved with care and service of Christ. I am grateful for the Caring and Sharing Committee who show love through preparing and serving food that nourishes.

During the month of April and beyond, the office technology was giving us problems. The computer was not functioning well. The telephone was not working at times. I would like to thank Joe Novak for working diligently on our computer system, finally determining a new system was needed. A big thank you to the Women's Guild who donated the funds making the new computer possible. The new computer is faster and much more efficient. It is a blessing for First Lutheran Church. The computer software had been giving us problems as well, but we have been working through these issues. Weekly newsletter issues had been sent, but our monthly newsletter was restarted as of August 2018. Any member running a program or event is encouraged to share a short write up about what is happening with the church office so it may be included in our newsletters. 2018 First Lutheran Youth Annual Report

- As there is only one youth who is active in our congregation, coordinating events has become a challenge.
- In February, FLY collected money for Souper Bowl Sunday. Donating \$195 to Bread for Life.
- March we held First Wing Fest. This year FLY challenged all First committees and groups to participate. The Fair Committee, Steve Sabia and Virginia and Sandra A. rose to the challenge. There were 71 in attendance. This event was held in conjunction with Bread for Life, whose Chef Bob also made wings. Missy Cipriano attended and served up some wings along with Hannah Ferris and other volunteers. Funds raised were shared with Bread for Life and FLY made a donation of \$340 to the organization. Bread for Life is looking forward to partnering with us again in 2019.
- Six final exam care packages were assembled, and then shipped the first weekend in May. Due to declining congregation participation, no care packages were shipped in November.
- FLY did not attend HammoConnect @ Calumet in September.
- In October our second Corn hole tournament was held. This event was well attended by folks from outside our church community. With the assistance of the Fede and Schmidt families and Keith Gray as MC this event was a huge success. All who attended expressed a desire to return. Seven teams participated in the tournament. The Fair committee started planning for the 2018 Church Fair in December 2017. The committee was comprised Kim and Keith Gray, Becky Fede and Joan Traini. The committee met monthly up until May to discuss the tasks associated with the coordination of the event, including but not limited to the Bake Sale, Vendor tables, Advertising, Raffle table, Kitchen, Volunteers, and the \$2 raffle ticket. All other communications were done on Sunday's during coffee hour, via email and text. The committee was able to obtain donations from private sources and local restaurants to offer three of the four prizes on the \$2 raffle ticket; a quilt made by Dotty Novak, a 55-inch Smart TV, and \$250 in local restaurant gift certificates. Just as last year, we had to purchase the TV prize for the raffle. The cost of this was offset by Easter Breakfast, hosted by the Fair Committee. The committee also received four Silent Action items.

Just over 400 people came through our doors to visit us in November. This is a significant drop from last year's attendance of 679. 2018 saw several changes, some new, some from past events. We sold vendor space in the Connector, moving the cupcake walk into the Narthex. This allowed us to accommodate 32 crafters/vendors to sell their wares, some with multiple table spaces. While we strive to ensure that all of vendors sell unique products, we did have some duplication this year. Feedback from our vendors and guests continues to be very positive with regards to the organization and layout of the fair. We continued to have the flow of traffic of attendees enter through the Narthex. The doors were left open so that all could view our beautiful sanctuary. Another change introduced this year was the addition of a 50/50 raffle.

Fortunately, with the 2017 balance and available special funds we were able to cover our operating expenses and virtually break even for the year. As displayed below, our annual expenses significantly exceed our weekly contributions by \$26,000. The accumulation of funds from previous years once again kept us solvent.

Our useable income received during the year decreased 5%. Refer to the ICON Fund Summary for our income by category. Everyone did a good job to reduce expenses by 6%. Salaries accounted for 63% of our expenses, while property maintenance and insurance represented 30% of the total. The Annual 2018 Performance Report displays our operating income and expenses in detail for the year and compares our actual annual expenses to the 2018 budget.

Many of our congregational members were very busy again this year successfully conducting several First Lutheran events. In total they made over \$17,000 with minimal offsetting expenses. The distribution on these funds is governed by the Council and Committee Members. Further, they must consider the need to recognize local interest in these events by returning funds to our community.

The Balance Sheet shows our financial condition as of December 31, 2018. Our assets consist mainly of cash and investments. The Equity section mostly displays balances held in trust for a special purpose or group.

Considering the results of the past few years, we will likely have sufficient discretionary funds, including Parsonage income (\$10,000), Holiday Collections (\$5,000), and interest (Memorial and Treasury) to support our 2019 needs. It is important to note that we have not incurred any major property repairs for some time. Eventually we will have to address this issue which will shorten our proposed time line. If we encounter property needs in 2019 or the same pattern continuous into 2020, the Council and Congregational members will have to seriously consider addressing the use of restricted funds such as Vacation Bible School, Pew Cushions, and Fuel fund accounts, as well as Memorial Funds. All of this is pretty much in line with what we discussed in previous years.

The Finance Committee and Council presents a proposed 2019 budget with a 3% increase. Property Services and Utilities line items have been slightly advanced to reflect increase costs.

For some time the Finance Committee has held donations for several charities including Manna, Sun Shine, God's Goods and E-Service. They seem to appear without any instructions for distribution. We would greatly appreciate anyone's assistance in helping us forward these funds to the intended charity.

The finance Committee recognizes the significant support and generosity provided by current members. This support is greatly appreciated to help keep First Lutheran Financially stable. Further, the committee understands that our viability will necessarily have to be met through congregational expansion.
