#### Station

--He submitted the Damage and Needs Assessment for the PCEMA in regards to the July 10 flooding at the station. A copy was given to the Trustees for their records.

### MARCS Radios

--Beginning October 1, 2013 through June 13, 2015 Edinburg will no longer pay a user fee. After a conversation with MARCS at the Ohio Fire Chiefs' Conference, they have agreed to place radios in the Local Emergency Use Only category. After June 13, 2015 there will be a yearly charge but that rate is undecided at this time. Presently they are discussing a \$20 per year charge. *Hazmat Charge* 

--There was an oil release yesterday from a well on Booth Road. He presented pictures to the Trustees. He will prepare and send the billing information to Chris for a billing resolution to be drafted for the next Trustee meeting.

### 1512 Update

--The 1512 is fully stocked and in service as a functioning ALS unit answering multiple alarms while the 1511 was out of service for breaking problems.

Dispatch Rates

In Mayor Bica's letter dated June 6, 2013 he advised that it was his goal to provide dispatch rates by July 31<sup>st</sup>. He asked the Trustees if they have heard anything. They have not but they had requested to receive the rate information by September 1, 2013. Tim said there are other options if their rate comes back extremely high. He would like to wait until the rates are received from the City of Ravenna before discussing other options. All agreed.
