- **No public restrooms**
- **Hours are subject to change due to holiday schedules, etc.**
- A fee could be charged for tardiness outside of the above hours. The extra charge of \$20 would automatically be added to the billing.

Dogs:

- **STAY** in the vehicle while you check-in.
- All vehicle windows must be closed enough so dogs cannot jump out.
- Dogs in truck beds must be tied down.
- **Must be on a leash at all times** until handed-off to Critter Nanny Ltd.
- Collars **MUST** be tight enough to prevent dog from backing out of it.
- Retractable leashes are to be locked “SHORT” to eliminate wandering, peeing and pooping on the way to/from the Animal House.
- **DO NOT** let the leash out of your control at **anytime**.
- Dogs not good on a leash need a halti or gentle leader for the head. (Our shoulders and neck thank you for this!)

We prefer quick on/off equipment. Harnesses are difficult, especially at check-out time.

However, some breeds with a neck thicker than the head (ie. pugs), need a harness. They will still need a collar, as we will remove the harness while boarding.

- The **name must** be present on the collar or tags.
- **We do not walk dogs to/from your vehicle.**
- **No bathroom breaks between car and Animal House.** (Our noses thank you for this!)
- **No bathroom breaks anywhere on property** (Thanks!)

Cats:

- Please bring them in with you at check-in.
- They **must** be in a hard sided carrier.
- NO KITTIES should be on a leash going to or from the Animal House.
- “Break-A-Way” collars required versus a buckle collar, for safety (Thank you).

CRITTER NANNY VACCINATION REQUIREMENTS

(Your vet can fax this information to **(503) 759-3592.**)

Cats:

Rabies (state required): 1-3 years

Distemper (FVRCP): 1-3 years

Leukemia (FELV): 1 year

Flea Treatment: Current
(no later than 1 day prior to check-in)



All kitties/cats must be **worm free**, especially if they go outside or are under 6 months of age.

Cats 6 months of age or older must be spayed or neutered to board.

Dogs:

Rabies (state required): 1-3 years

Distemper: 1-3 years

PARVO: 1-3 years

Bordetella (Kennel cough):
Every 6 months if given by injection or nasal.
Every 12 months if given orally.

Flea Treatment: Current
(no later than 1 day prior to check-in)

All dogs must be **worm free**, especially if around poultry or horses, go hunting, camping, swimming in ponds/rivers/lakes, etc.

Dogs 6 months of age or older must be spayed/neutered to board or attend doggy daycare.
