December 2015 Final Audit Report

Mr. Ackerman clarified that we do have proper checks and balances in place to assist with incoming checks, deposit, etc. He also shared that checks written for greater than \$5,000 require two signatures.

Goal Review & Strategy Considerations

Mr. Johnson shared that Senior Staff met offsite to create goals for each of the three outcomes.

He led the Board through a discussion to review the goals and discuss potential strategies under each one.

• Outcome #1 – Goal 3 – change to read: Encourage participation and aid in continuing education opportunities.

Mr. Johnson stated he would integrate discussion items from today and Senior Staff will meet once again to revise the goals and incorporate suggested items.

Camp Luther Nomination Process Discussion

President Lueck shared past history of the Camp Luther Board of Directors nomination process. In December 2016, Ken Longmire (Commissioned Minister) and Michael Hartman (Lay) will have completed their two three-year terms and will not be eligible to remain on the Camp Board. At our November meeting we will be voting for a commissioned and lay member to replace them. In an effort to be proactive, in mid-August we will be sending out the job description and a nomination form for District Board members to submit names. Please make sure that individuals are willing to serve prior to submitting their name on the nomination form. District Board members can submit as many names as you like.

District Ministry Overview

Rev. Dan Kohn was invited to provide an overview of his responsibilities to the North Wisconsin District as District Counselor. Rev. Kohn provided a snapshot of his activities over the last year and a half, as well as shared his goals for the future of this service.
