Owner acknowledges that at the date this agreement is signed, the fees, hours, and requirements for use of daycare services are outlined below and on any attachments hereto. Owner understands that Precious Pets management reserves the right to alter or amend the fees, hours, and requirements at any time.

- Use of daycare services are to be provided only to the dogs listed above. New dogs may be added to this contract and utilize daycare and sleepover services on passing their enrollment/social evaluation.
- Precious Pets business hours are:
 - Monday-Friday 7:30 am – 6:00 pm
 - Saturday 7:30 am – 5:00 pm
 - Sunday Closed
- Daily daycare fees are due at the time of pick-up. In the case of payment through a punch pass, all twenty (20) punches will be paid for in advance.



4. Daycare charges are:

- Four (4) or less hours → Half-Day \$14 + tax
Four (4) hours or more → Full-Day \$20 + tax

Any late pickups without being pre-arranged with management will be required to pay a late fee.

Late pick-up fees are as follows:

- Immediate \$10 charge + tax after 6
Additional \$15 + tax after 6:15
Any dog not picked up by 6:30 will be boarded and charged for the night and also for shuttles to and from the country resort

OWNER AGREES

1. That in admitting my dog(s) to the facility, Precious Pets has relied on my representation that my dog(s) is/are in good health, does not currently have and has not had within the last ten (10) days any communicable diseases, and has/have not harmed or shown serious aggressive or threatening behavior towards any person or any other dog.
2. That any problem that develops with my dog(s) will be treated as deemed best by owners and employees of Precious Pets in their sole discretion, and that I assume full financial responsibility for any and all expenses involved.
3. If my dog shows signs of aggression towards any employee or dog alike we have the right to pull them from daycare services until an evaluation is complete by **Kota Center** behaviorists.
4. To pay for all services rendered and fees assessed as described in this agreement.
5. To provide proof of required vaccinations for each dog utilizing center annually.

RELEASE AND WAIVER OF LIABILITY

Although supervised playtime, please remember there is likely hood of scratches from playtime.

Precious Pets has created a dog center for dogs and their owners to enjoy. I understand that the use of the dog center means that I am taking certain risks of damage or injury to myself, my guest(s), my property, my dog(s), and to others in the center. I realize that when dogs are around people and other dogs, some accident or injury may result, and that people, dogs, and property might be injured or damaged.

I also agree to be responsible for myself, my guest(s), and my dog(s) and for any liability caused by me, my guest(s), and my dog(s), and that I will hold harmless and indemnify Precious Pets and its owners, members, employees, successors, assigns, and all affiliated parties from any and all liability, claims, demands, causes of action, loss damage, or injury to person or property, including any death and serious injury which may be caused by myself, my guest(s), or my
