MISS MILWAUKEE AREA SCHOLARSHIP ORGANIZATION/MISS AMERICA SCHOLARSHIP FUND
RULES AND REGULATIONS

THE MISS AMERICA SCHOLARSHIP FUND THROUGH THE MISS MILWAUKEE AREA SCHOLARSHIP ORGANIZATION OF WISCONSIN WILL AWARD SCHOLARSHIPS UNDER THE FOLLOWING CIRCUMSTANCES:

1. ALL FOLLOWING CONDITIONS ARE MET BY MISS MILWAUKEE AREA 2019/MISS MILWAUKEE AREA'S OUTSTANDING TEEN 2019 (HEREAFTER "THE TITLEHOLDER") :
 - a. THE TITLEHOLDER SHALL ATTEND ALL APPEARANCES SCHEDULED BY THE MISS MILWAUKEE AREA ORGANIZATION. MANY APPEARANCES WILL BE SCHEDULED PRIOR TO JULY FIRST. **ALL APPEARANCES SCHEDULED BY THE TITLEHOLDER MUST BE APPROVED BY THE EXECUTIVE DIRECTOR.**
 - b. THE TITLEHOLDER SHALL WRITE THANK YOU NOTES TO ALL SPECIFIED SPONSORS. SHE WILL BE PROVIDED POSTAGE FOR SAID SPONSORS. ADDITIONAL POSTAGE WILL BE THE RESPONSIBILITY OF THE TITLEHOLDER. SHE WILL RECEIVE A COUNTED AMOUNT OF OFFICIAL MISS MILWAUKEE AREA STATIONARY CARDS. ANY ADDITIONAL STATIONARY MUST BE REQUESTED THROUGH THE EXECUTIVE DIRECTOR.
 - c. THE TITLEHOLDER WILL BE GIVEN THE OPTION TO ATTEND THE "MISS MILWAUKEE AREA SEND-OFF AND SHOWING" HELD LATE MAY/EARLY JUNE. ONCE SHE HAS COMMITTED, THE DECISION SHALL STAND AND SHE IS EXPECTED TO ADHERE TO THE DECISION. ALL COMPETITION WARDROBE SHALL BE WORN, AND STATE TALENT PIECE SHALL BE PERFORMED AT THIS OCCASION.
 - d. THE TITLEHOLDER SHALL ATTEND ALL SCHEDULED APPEARANCES AND COMPETITIONS FOR "MISS WISCONSIN PREP DAY" (HISTORICALLY A SATURDAY IN APRIL), AND THE "MISS WISCONSIN COMPETITION" (HISTORICALLY A FULL WEEK IN JUNE).
 - e. THE TITLEHOLDER SHALL ATTEND AND FULFILL OBLIGATIONS, WHICH WILL INCLUDE BUT ARE NOT LIMITED TO: EMCEE, PERFORM STATE TALENT PIECE WEARING STATE COMPETITION WARDROBE, SHOWCASE STATE EVENINGWEAR, WALK-ON GOWNS, MERCHANT DINNER APPAREL, COCKTAIL DRESSES, AND STATE EVENT GOWNS AT THE 2020 MISS MILWAUKEE AREA COMPETITION (HISTORICALLY THE LAST SATURDAY OF FEBRUARY). SHE SHALL ATTEND PRIOR REHEARSALS.
 - f. AT WORKSHOP/INFO MEETINGS LEADING UP TO THE OUTGOING TITLEHOLDER COMPETITION SHOW, THE TITLEHOLDER SHALL DRESS PROFESSIONALLY IN CROWN, SASH, AND INTERVIEW APPROPRIATE STYLE CLOTHING INCLUDING FULL HAIR AND MAKE-UP.
 - g. THE UNDERSIGNED GIVES CONSENT FOR PERSONAL AND PROFESSIONAL PHOTOGRAPHS, INCLUDING ALL CONTESTANTS, THE MISS MILWAUKEE AREA ORGANIZATION COMPETITION AND/OR THE TITLEHOLDER TO APPEAR ON THE MISS MILWAUKEE AREA WEBSITE AND OTHER PUBLICATIONS.
 - h. NO CONTESTANT SHALL CANCEL HER PARTICIPATION WITHIN THE 2 WEEKS PRIOR TO THE MISS MILWAUKEE AREA COMPETITION AFTER SUBMITTING THE SIGNED/NOTARIZED CONTRACT AND/OR CONTRACT APPENDIX. IF A CANCELLATION OCCURS, THE MISS MILWAUKEE AREA'S EXECUTIVE DIRECTOR WILL BE THE FINAL DECISION MAKER ON WHETHER TO ACCEPT WITHDRAWN CONTESTANT FOR FUTURE PARTICIPATION IN **ANY** PAGEANT FOLLOWING THE CONTESTANT'S WITHDRAWAL.
 - i. IF A MISS MILWAUKEE AREA/MISS MILWAUKEE AREA'S OUTSTANDING TEEN CONTESTANT IS COMPETING FOR ANY OTHER TITLES BEFORE THE MISS MILWAUKEE AREA COMPETITION, SHE MUST MAKE THE EXECUTIVE DIRECTOR AWARE. IF SHE WINS A TITLE PRIOR TO THE MISS MILWAUKEE AREA COMPETITION SHE IS ENROLLED IN, HER COMPETITION SPOT WILL BE GIVEN TO THE NEXT PERSON ON THE WAITING LIST AND HER CONTRACT WILL BE CONSIDERED NULL AND VOID.
2. ALL OTHER RULES ARE FULFILLED:
 - A. WARDROBE FOR THE MISS WISCONSIN COMPETITION MUST BE APPROVED BY THE MISS MILWAUKEE AREA ORGANIZATION NO LATER THAN JUNE FIRST PRIOR TO THE COMPETITION. THERE IS NO WARDROBE ALLOWANCE AND WARDROBE ATTIRE IS THE SOLE RESPONSIBILITY OF THE TITLEHOLDER.
 - B. IF THE AWARDED MISS AMERICA CROWN OR SASH IS LOST/STOLEN/DAMAGED, IT IS THE FINANCIAL RESPONSIBILITY OF THE TITLEHOLDER TO REPLACE THE ITEM TO FULFILL HER YEAR OF SERVICE AT A PROFESSIONAL LEVEL. THE ITEM TO BE REPLACED MUST BE ORDERED THROUGH THE MISS MILWAUKEE AREA EXECUTIVE DIRECTOR. DELIVERY WILL TAKE PLACE APPROXIMATELY 3-4 WEEKS AFTER PAID REPLACEMENT FEE IS RECEIVED BY ORGANIZATION.

C. THE NAME OF THE TITLEHOLDER'S COLLEGE, UNIVERSITY OR OTHER ACCREDITED INSTITUTION WILL BE PROVIDED TO THE MISS MILWAUKEE AREA ORGANIZATION IN WRITING ON OR BEFORE THE DAY OF THE OUTGOING TITLEHOLDER'S COMPETITION SHOW: WHEN SHE CROWNS THE NEW WINNER. ALL SCHOLARSHIP MONIES WILL BE SENT TO THE INSTITUTION WITHIN 30 DAYS OF THE OUTGOING COMPETITION DATE, IF SAID REQUEST HAS BEEN SUBMITTED IN A TIMELY FASHION.

3. SCHOLARSHIP USAGE:

A. SCHOLARSHIP FUNDS MAY BE APPLIED TO TUITION, TEXTBOOKS, SUPPLIES, ACADEMIC FEES, HOMESCHOOL EXPENSES AND OTHER APPROPRIATE EDUCATIONAL EXPENSES. ALL UNUSUAL OR QUESTIONABLE ITEMS OF EXPENSE MUST BE SUBMITTED TO THE MISS MILWAUKEE ORGANIZATION IN WRITING. THE REQUEST MUST INCLUDE AS MUCH INFORMATION AND DETAIL AS POSSIBLE AND 30-60 DAYS PRIOR TO THE OUTGOING PAGEANT FOR CONSIDERATION OF APPROVAL. AMOUNTS RECEIVED AS SCHOLARSHIP PAYMENTS ARE TAXABLE AS INCOME TO THE EXTENT THAT THEY EXCEED "QUALIFIED TUITION AND RELATED EXPENSES".

B. QUALIFIED TUITION AND RELATED EXPENSES INCLUDE TUITION AND FEES REQUIRED FOR ENROLLMENT OR ATTENDANCE OF A STUDENT AT AN EDUCATIONAL ORGANIZATION, INCLUDING FEES, BOOKS, SUPPLIES AND EQUIPMENT REQUIRED OF ALL STUDENTS IN THE PARTICULAR COURSE OF INSTRUCTION.

C. PAYMENT OF ALL APPROVED EXPENDITURES WILL BE MADE DIRECTLY TO THE COLLEGE, UNIVERSITY OR OTHER ACCREDITED INSTITUTION UNLESS EXTENUATING CIRCUMSTANCES EXIST. IN SUCH CASES A LETTER OF EXPLANATION ACCOMPANIED BY PAID RECEIPTS AND/OR COPIES OF CANCELLED CHECKS WILL BE REQUIRED WITH QUALIFY THE EXPENSE FOR REIMBURSEMENT TO THE PAYER OR SCHOLARSHIP CONTESTANT.

D. A TITLEHOLDER WHO RECEIVED A SCHOLARSHIP AT THE STATE LEVEL MUST USE THE SCHOLARSHIP EARNED AT THE LOCAL LEVEL PRIOR TO APPLYING FOR FUNDS AT THE STATE LEVEL. VERIFICATION MUST BE SUBMITTED IN WRITING FROM THE LOCAL DIRECTOR THAT ALL LOCAL SCHOLARSHIP FUNDS HAVE BEEN EXHAUSTED.
