The City Council of the City of Vienna met in regular session, Wednesday, March 6, 2019 at Vienna City Hall with the following members and guest:

There being a quorum, Mayor Simmons called the meeting of the Vienna City Council to order at 6:30 p.m.

### **NEW BUSINESS**

Alderman Hill made a motion to Approve the Omnibus Consent Agenda consisting of the February 20, 2019 Council Meeting Minutes and the Warrant (\$37,895.81). Alderman Riddle seconded the motion. Motion carried, all in favor.

#### **PUBLIC COMMENT**

Brennan Dahncke was present to address city officials with an apology for being involved in recent vandalism at the city park. Dahncke expressed his regret for his actions. Chief Miller said this investigation was still ongoing as several juveniles were involved and would therefore go before the states attorney. City officials thanked Dahncke for attending.

# CITY ELECTED AND APPOINTED OFFICIALS

Mayor Simmons briefly mentioned the city was bringing in approximately \$2,500.00 per month in gaming revenue.

Clerk Wright informed council a zoning meeting was scheduled March 18th for review of the 2019 zoning map per zoning changes in 2018. Wright said the city would be passing an ordinance at the next scheduled meeting adopting the new map.

Supt Racey said the replacement of water valves at the location of South 4th and Locust Street would be scheduled for the morning of Monday, March 11th. Racey said water would be shut off for several hours for repairs. Racey also said there would be two bids on the cut/cap waterline project submitted to the city.

Chief Miller discussed citations issued to 407 North 11th Street for ordinance violations of the property's condition. Miller also announced the annual "National Night Out" event to take place at the city park Tuesday, August 6th.

Fire Chief Williams spoke with city officials of setting a date for the annual firework display. Council decided on Friday, July 5th since the city's lead shooter was already booked for the fourth. Williams said he was checking with a new fireworks display company as the prior year's company was no longer servicing Illinois. Williams requested permission to put in for a 50/50 grant opportunity with IDNR. Council gave consent.

Phil Morris, Depot discussed a fundraiser for city Christmas lights with the assistance of Modern Woodmen and Johnson County Revitalization. Morris said a silent auction would be held at the Junque Jamboree on Saturday, April 6th to raise funds.

Alderman Tuey and Hill spoke of organizing a community Easter egg hunt that would take place at the city park on Saturday April 20 at 1:00 p.m.

Alderman Tuey discussed several ideas for community oriented events with council.

As there was no further business to discuss, Mayor Simmons declared the meeting adjourned at 7:20 p.m.
