## • Monthly Financial Report

The balances for all accounts as of August 31, 2021, are as follows: Checking - \$973.67; Investment Savings - \$329,330.79; and Town CD's - \$131,922.04. Total town funds - \$462,226.50. Stands as read subject to an audit with the clerk.

#### Town CD Renewal

Treasurer Much researched some CD rates for Town funds of \$132,111.39 coming due soon. Community First—15 months/1% Wolf River—12 months/.25% Fox Communities—12 months/.70% First State—12 months/.11% Knapp made a motion, seconded by Griffin, to renew the CD in the amount of \$132,111.39 at Community First for 15 months at 1% interest. ### **Outagamie County Sheriff's officer report (if in attendance)**

The Officers introduced themselves and reported that there have been a lot of vehicle break-ins in Outagamie County as a whole. There's nothing to report in Maple Creek, but residents should be aware of the vehicle break-ins.

### Specific matters for discussion and possible action:

A. Plan Commission: Approve Hintzke family CSM; On-line PC training \$20

The Plan Commission approved the final Hintzke family CSM that will be reviewed by the County Zoning. If approved, the clerk would like the CSM number and date mentioned in the motion so that there are no changes when it comes back from the County and the clerk and the chairperson can just sign it. After discussion, <u>Knapp made a</u> motion, seconded by Griffin, to approve the Hintzke CSM, project #8640csm, dated 9-1-21. Ayes 2, Opposed 0.

B. Roads

• Rob Schweitzer-Close part of Schweitzer Road

Rob/Holly Schweitzer would like to close part of Schweitzer Road on Saturday, September 25<sup>th</sup> from noon to about midnight. Supervisor Knapp stated that barricades would be needed. They can be rented from the County for \$120. Also, Schweitzer Road is a border road shared with the Town of Deer Creek. Permission from the Town of Deer Creek would also be needed. This subject is on Deer Creek's agenda tomorrow night. Supervisor Knapp will attend their meeting. Any motion made should be conditional upon the Town of Deer Creek's approval, also. <u>Knapp made a motion, seconded by Griffin, to approve closing Schweitzer Road from Postel Road to Buboltz Road on Saturday, September 25, 2021 from 12 p.m. to 12 a.m. for Rob/Holly Schweitzer party conditional upon the use of proper signage/barricades and the approval of the Town of Deer Creek Town Board. Ayes 2, Opposed 0, Abstain 0, Absent 1. MOTION CARRIED. Griffin made a motion, seconded by Knapp, to approve calling a Special Meeting of the Board if any new information comes from Deer Creek's meeting and needs to be acted on. Ayes 2, Opposed 0, Abstain 0, Absent 1. MOTION CARRIED.</u>

• Fall ditch mowing

Chairperson Griffin will call the County Highway Department to get the fall ditch mowing done.

Road Certification Report

This needs to be filled out every year. It records roadwork done this year and certifies the roads available for public use. The maps were sent to the Chair.

• Affeldt Road-Excavating sink holes

We received an email from Chad Johnson, County Highway Dept., stating that he doesn't think that grader patching is the right course of action on Affeldt. He thinks the sinkhole areas should be excavated, hauling out that material, fill them with stone and then patching the roadway with asphalt. The estimated cost would be \$4,000. He also mentioned that the culverts are in and have been asphalt patched. <u>Knapp made a motion, seconded by Griffin, to approve</u> excavating the settled areas on Affeldt Road, put in breaker run and then asphalt those areas for a total of \$4,000. Ayes 2, Opposed 0, Abstain 0, Absent 1. MOTION CARRIED.

• River Road-Pulverize and grade

We received an estimate from Chad Johnson, County Highway Dept., to pulverize, grade and compact our portion of River Road for \$1,000. He contacted the Town of Liberty and they will do their portion of the road also. *Knapp made a motion, seconded by Griffin, to accept the estimate from the County Highway Dept. to pulverize, grade and compact our portion of River Road for \$1,000. Ayes 2, Opposed 0, Abstain 0, Absent 1. MOTION CARRIED.* 

• Postel Road-Possible Highway encroachment

Supervisor Knapp has been researching options for a possible encroachment issue on Postel Road. A land owner has installed tile lines that end by a culvert on Postel that has washed out and needs to be fixed. Wisconsin Stats. 86.04 deals with highway encroachments. More information is needed before the land owner is contacted.

• LRIP (Local Road Improvement Program) Outreach meeting invitation

Chairperson Griffin will attend this webinar on September 29th.

• Separate Road meeting request

Supervisor Knapp would like to set up a meeting where we only discuss roads. A separate meeting has been set up on Monday, November 1<sup>st</sup> starting at 6:00 p.m. to discuss roads, set up a 5 year plan and WISLR reporting.
