Motion by Marugg, seconded by Risser to approve the agenda. Ayes: all, carried. Council reviewed August listing of bills to be paid, minutes from 08/26/2019 and 09/05/2019, August 2019 Treasurer's Report, and a Fall ECIA clerk meeting on 11/06/2019 from 8:30AM-2:30PM. Langel questioned the Visa charges for supplies and the separation between the two payments. Manternach replied that one payment is for liquor for the Memorial Hall and the other payment is for general streets/city hall supplies and advised the actual charges are available for review. Motion by Engler, seconded by Risser to approve the consent agenda. Ayes: all, carried.

Citizen Concerns: K. Massey questioned the status of the Pit Bull situation. Manternach explained we are waiting on the magistrate to approve an administrative search warrant in order to enter the property to obtain the dogs to get their DNA tested to confirm their breed. Manternach explained we do have a recording of the dog owners confirming the Pit Bull breed, but we still need to follow the procedure outlined in the ordinance. M. Massey inquired if Rottweilers were allowed in town. Manternach advised Rottweilers are not a defined dangerous dog breed in our ordinances, thus would be allowed in town. Jaeger expressed his frustration with barking dogs. Manternach explained once we receive three different complaints regarding the same barking dog, from three different property owners, we can proceed with fining the property owner/owner of the barking dog. Trumm advised this ordinance made the process harder to complain about a barking dog. Manternach responded, prior to this ordinance, there were no repercussions for owning a barking dog in which this ordinance addressed that with the fine. Jaeger inquired if licensing a dog would be a possibility. Manternach advised she would look further into this potential. Jaeger inquired when a flap would be put on the intake on the East End. Wenger advised he would contact Jaeger
