1. Rotary Press Upgrade

Project would require a Part II permit which will take 6-10 months.

Leadtime for press is an additional 8-10 months.

Project was previously submitted for a grant.

Grant was not announced at the November CFA Board Meeting.

2. GIS Base Mapping

ESRI (Environmental Systems Research Institute- has an annual fee for the administration account of approximately \$550.00 per year.

Additional accounts are approximately \$250.00 per year.

Account fees are payable by CMSA.

Project is 95 percent completed.

Scheduled to be completed by the end of the year.

3. PENNVEST Funding

Planning and construction meetings were held via phone with PennVest.

Project cost estimated at \$2,700,000.00, includ4es press, Jones Street extension, and pump station screen.

PennVest anticipates the project to be 100% loan (1.0% for year 0-5, 1.743% for years 6-20).

Monthly payments of \$13,332.60 or \$12.52 per customer.

Operating with \$51,000.00 per year in black.

\$8.53 per customer monthly fee increase if the annual \$51,000.00 is applied.

UER, WQM Part II, Wetland Reports are required.

Jones Street extension was submitted for the LSA Statewide Grant.

- > Downloaded flow meters replaced the batteries.
- Plants flow meters had the annual calibration.
- A spare grinder pump was delivered.

- Eckenrodes used a sewage camera to diagnose the Benscreek problematic manhole, there was nothing wrong with the inside of the sewer main, it was decided that the sewer main elevation is incorrect and no allowing solids to flow. A suggestion of hydraulic cement to permanently change the elevation of the sewer main at that manhole.
- Alarm call for generator radiator hose has ruptured, was able to temporarily repair it, Bridgeway can send CMSA a replacement hose.
- > The blower motor that was problematic was sent out for repair and returned-CMSA has a spare.
- ➤ Knopp and Klatt completed a site survey of the wastewater treatment plant, to plan paving, stormwater drain, and a pad for planned storage unit/trailer.
- Penelec was in to install monitoring equipment to track the electrical surges at the plant. No power surges were recorded from the outside line into the plant.
