19 Peter S. Davis, as the court appointed Receiver, respectfully petitions the Court as
20 follows:

21 1. On August 18, 2016, this Court entered its *Order Appointing Receiver*, which
appointed Peter S. Davis as Receiver of DenSco Investment Corporation (“Receivership
Order”).

1 2. Pursuant to *Order Re: Petition No. 1*, the Court approved the Receiver's
2 compensation at the rate of \$250.00 per hour together with all reasonable costs and expenses
3 incurred relating to these services as Receiver. These services are billed by and paid to the
4 Receiver's firm, Simon Consulting, LLC.

5 3. Pursuant to this Court's *Order Re: Petition No. 1*, the Receiver has engaged the
6 services of the law firm of Guttilla Murphy Anderson, P.C., of Phoenix, Arizona, and the
7 Receiver has agreed to pay the law firm compensation at agreed hourly rates for the services
8 of the firm together with all reasonable costs and expenses incurred on behalf of the Receiver.

9 4. Pursuant to this Court's *Order Re: Petition No. 10*, the Receiver has engaged
10 the services of the law firm of Frazer Ryan Goldberg & Arnold, LLP of Phoenix, Arizona and
11 the Receiver has agreed to pay the law firm compensation at agreed hourly rates for the
12 service of the firm together with all reasonable costs and expenses incurred on behalf of the
13 Receiver.

14 5. Pursuant to the Court's *Order Re: Petition No. 2*, the Receiver is authorized to
15 file this fee petition without including as exhibits the itemization of services rendered to, and
16 costs incurred or expended on behalf of, the Receivership, provided that the fee petition
17 includes a statement that anyone desiring additional information concerning the services and
18 costs to be paid under the fee petition may obtain redacted information from the Receiver by
19 delivering to the Receiver and the Receiver's counsel, Guttilla Murphy Anderson, P.C., a
20 written request specifying the additional information requested at least three (3) days prior to
21 the date set for any hearing on the fee petition. The Court's *Order Re: Petition No. 2* further

1 provides that upon request of the Court, the Receiver shall make available for in camera
2 review by the Court the itemized statements and supporting documentation for the services
3 and costs to be paid under the fee petition.

4 6. The Receiver has submitted an itemized statement for services rendered to this
5 Receivership by the Receiver and his firm, Simon Consulting, LLC, and for reimbursable
6 costs incurred or paid during the period May 1, 2018 through May 31, 2018. The total
7 amount requested for payment by the Receiver is \$10,754.85. The Receiver believes that this
8 amount is reasonable and should be paid from the Receivership Assets.

9 7. The law firm of Guttilla Murphy Anderson, P.C., has submitted an itemized
10 statement for services rendered to this Receivership and for reimbursable costs incurred or
11 paid during the period from May 1, 2018 through May 31, 2018. The total amount requested
12 for payment by the law firm of Guttilla Murphy Anderson, P.C. is \$11,590.14. The Receiver
13 believes that this amount is reasonable and should be paid from the Receivership Assets and
14 has therefore approved this statement for payment.

15 8. The law firm of Frazer Ryan Goldberg & Arnold, LLP, has submitted an
16 itemized statement for services rendered to this Receivership during the period May 1, 2018
17 through May 31, 2018. The total amount requested for payment by the law firm of Frazer
18 Ryan Goldberg & Arnold, LLP is \$670.00. The Receiver believes that this amount is
19 reasonable and should be paid from the Receivership Assets and has therefore approved this
20 statement for payment.

3 1. The amount of \$10,754.85 to Simon Consulting, LLC, for services rendered to
4 the Receivership and costs incurred during the period from May 1, 2018 through May 31,
5 2018;

6 2. The amount of \$11,590.14 to Guttilla Murphy Anderson, P.C., for services
7 rendered to the Receivership and costs incurred or paid during the period May 1, 2018
8 through May 31, 2018; and

9 3. The amount of \$670.00 to Frazer Ryan Goldberg & Arnold, LLP, for services
10 rendered to the Receivership during the period from May 1, 2018 through May 31, 2018.
