It is with great sadness that we let our community know of the recent passing of Larry Smith, Southwyck CAI director for 6 years.

One day you see Larry out working around his yard like he usually could be seen doing and the next you learn he is in the hospital and then that he had cancer and just as quickly, that he had passed away. Larry was a hands on kind of guy. Working in his yard nearly every weekend, volunteering with Southwyck CAI and the Pearland Community Police Assoc. He enjoyed weekend visits with his grand kids and at the age of 76 was still working as a controller at HP Piping Solutions LLC. Larry moved to Southwyck in 2008 and by 2010, was running for a board position. Larry valued being a homeowner and as Larry wrote in his bio for a board position, he was drawn to Pearland because of its beauty, proximity to services and shopping, safety and the people. He recounted that he and his wife spent their weekends for months becoming familiar with Pearland by going to the movie theaters, restaurants and shopping while they scouted the neighborhoods trying to decide where they would make their new home. Larry mentioned that they noticed the well-kept lawns with older trees and wide range of colorful flowers in the subdivision and the lack of 'junk' or other eyesores in the yards and on the streets. They loved the many neighborhood parks and noticed that people gathered there and actually used them! They loved that our parks were well maintained as well. Larry and his wife use to make evening trips to Southwyck and noticed that not

only were the entrances and streets well lit, but also most all of the neighborhood homes had their porch lights and garage lighting turned on. He noted that 'before you actually move into a neighborhood, it's tough to know how the neighbors will be. We had noticed many people out walking their dogs, jogging and riding bikes.' Larry and his wife valued the diversity of the people they saw both in ages and nationalities. Many of the people they saw waved, smiled and seemed very friendly and they liked that. Larry recounted that they found out how truly wonderful his Southwyck neighbors were after hurricane Ike shortly after they had moved in. People shared food, generators, ice and support. Larry felt like the Smith family had made the right choice in picking Southwyck as their home.

Larry will be greatly missed on the Southwyck CAI board. He was a contributor and not an antagonist. He was a staunch supporter of keeping dues from being raised and he shared his expertise and knowledge about all kinds of things when we had a project going on for the association such as the pergola at Southwyck Sunset Park or the brick columns on Fite Road. Larry freely and generously gave of his time to us in Southwyck and Pearland plus numerous other organizations throughout his life. We are also thankful that Larry did not have to suffer long and he had his family by his side as he made his final journey. Hear a rumor of something dealing with the HOA and you want to know more about it? Contact your HOA board. Attend an HOA meeting. Your HOA generally hears very little from the homeowners directly which is a shame. You want to complain about a notice your HOA gave you? What do you do? Should you toss it in the garbage and then trash talk your HOA on as many social media site as you can find? No. Are you looking for a real answer or something else? Contact your HOA if you are looking for an answer. Want to know if your HOA followed up on your complaint to them about a trailer parked in your neighborhood for over 2 months? What should you do? Contact your HOA and find out the status of your complaint. Is your neighbor shooting his gun off in his backyard? Who do you call? Contact the police by dialing 911. There are some things your HOA should handle and there are some things they do not handle.

There is not one of us that want to ever be the ones who would think of raising our assessments. We have a healthy reserve fund to cover most incidents to our property, but it is not over funded. We continue to repair, replace and add when needed every year. Our board works together to come up with needs and wants and we have a budget that we work from. We care how our community looks and we care how much you (and us) pay into our association. While it is not a requirement, we do happen to have some board members who are accountants, controllers, or who work with budgets in their jobs. We do not budget or spend more than we take in. This board takes their responsibility as board members of Southwyck CAI very serious. All of us are active participants in the decision process for our association, Southwyck CAI. We have a reserve fund, we are insured, we have a reserve study, we budget, we have audits, we have open meetings, we encourage participation, we have, up until recently, a full board of directors to help run our association and we are homeowners too.

MAKING RESERVATIONS TO USE THE SOUTHWYCK LAKE PARK


We have a number of groups that regularly reserve our park for weddings, family reunions, triathlons, school picnics, ceremonies, exercise groups and more. It's a popular site for many activities. Individuals, groups or organizations with ties to our community wishing to reserve part of the Southwyck Lake Park for their use, need to contact our management company, CMSI at 281-480-2563 to make a reservation and fill out a short form giving your contact information. The form is also located at our website, http://SouthwyckTexas.com under the Documents & Forms page. Scroll down to the bottom of the page and you will see the link to the Southwyck Lake Park Release Form and Rules.

While we still allow our homeowner access to the park during your function, we do allow you to reserve the pavilion for your use and bring in some equipment for your function. The benefits of making a reservation are, we know how our park is being used and we then understand what additional equipment we might want to provide for the parks; we can help you promote your activity if you wish and if given enough time; we make sure that park maintenance does not occur during your function like the sprinklers going off or mowers mowing; we will not run off your group that may take over the pavilion or other area for their activity; you receive clear rules for the park so that you know what is expected from your group with regards to the care of our park.

Currently, we do not charge for you to use our park, however, donations are always appreciated and go to help maintain our parks. Please remember, NO VEHICLES in the park unless you have contacted us for approval. We have irrigation lines throughout the park areas. If porta potties are to be available at your event, they are never to be placed at the pavilion. We will direct you were the acceptable place is to put them. Because you were given permission for your event one year does not mean you do not have to get permission the next. You do. Do not ruin your event by not getting permission. Also remember to plan in advance. Requests are approved by the board when they meet the 1st Thursday of the month.

- play equipment, picnic tables, benches, swings, water fountains & foot washing station, volley ball court, sand box, trash cans and doggy stations & bags in our 2 parks
- upkeep of the lake including chemicals, trash removal, pump and fountain (coming soon)
- covered structures at 2 parks

The fastest finisher in this year's Silverlake Sprint Triathlon was local Pearland resident Matthew Murray, a senior at Glenda Dawson High School, with a time of 46 minutes 15 seconds. Matthew was among the 15% of 350 total athletes who raced in this year's Sprint and Olympic events from the Pearland area. Other participants came from the Houston area and as far away as Scotland, England, Mexico, Hawaii, Nebraska and Colorado. Held annually at the Southwyck Lake Park in Pearland since 2006, the Silverlake Triathlon supports many local youth organizations including the Boy Scouts of America, several Dawson High School sports

teams, and the Dawson High School choir, as well as the Texas Gulf Coast Chapter of the Leukemia and Lymphoma Society. Race Director Gaye Koenning, a local Pearland resident, started the race 10 years ago to provide opportunities for local families to race triathlon at home. She hopes that someday a local Pearland youth who started their triathlon racing career at the Silverlake Tri will race in the Olympics.
