After discussion, all voted in favor; motion passed. Public hearing for alley closure set for June 8th at 6:30 p.m.. A motion was made by Collier and seconded by Peterson proceed with the purchase of a mower with rear discharge. After discussion, Knapp, Peterson, Collier voted in favor Fish abstained; motion passed. A motion was made by Fish and seconded by Collier to approve the closure of Nebraska Avenue from 1 p.m. to 2 a.m. on May 29th and 30th. After discussion, all voted in favor; motion passed.
