

Preparation for General Pest Control and Inspection

On the above date a technician from EAKO Pest Control (508.588.5897) will be inspecting and treating your units for pest(s) (ants, cockroaches, mice and bed bug inspection). Prior to the inspection/treatment the following preparations are necessary to be able to inspect and achieve proper control. Due to the service provided and the probability of pest(s) in the building, these control procedures will be performed to protect you and the other residents of the building.

How to Prepare for the Service:

Any concerns regarding sensitive health conditions with the use of any listed pesticides, please consult with your physician. Please clear out kitchen, bath area cabinets and closets. Clear areas where you have seen pest activity and items should be cleared away from the walls and window sills/sliders. Cover and put away any and all exposed food items. If a perimeter spray is deemed necessary, please be prepared to leave your unit during the service (will need to remove all pets from residence, unplug fish tanks) and be out of the unit for up to 3 hours.

The treatment(s) may consist of applying bait to corners of cabinets, cracks/crevices, baseboards, under kitchen appliances and around trim (ants, roaches, mice). The technician may also deem it necessary to apply dust into voids/cracks/crevices and inside of walls (ants, roaches, mice). Liquid pesticide application (spray) may be deemed necessary to the perimeter of your unit and the technician will inform you if you need to leave the unit. If the technician finds any bed bug activity, the report will be given to management and your unit will be scheduled to be treated on a future date (management will notify).

- •Provoke Bait (non-toxic, EPA exempt)
- •Pur Black foam (carbon, polyurethane, EPA exempt)
- Vendetta Nitro (clothianidin, pyriproxyfen, EPA reg # 1021-2796)
