

Running Order and Class Information

Please check all your trial information carefully on the confirmation you were sent and notify me immediately in writing with any corrections. You can contact me via email at LKSAGE@aol.com or by phone (503) 840-4303 (cell), email preferred.

SITE INFO: This trial will be held in two rings indoors on packed dirt. Crating is on concrete around the periphery of the rings. **You may set up your crating space Sunday night after 5pm.**

DIRECTIONS TO THE TRIAL SITE:

From I-5: Take EXIT 9 (in Washington), head West on 179th Ave. for ½ mile, turn left onto 2nd Ave., then turn left again at Gate 7. Exposition and Equestrian Bldg. is on the right, at the end of the road. Feel free to park in any marked parking spot around the arena building. Please do not block any arena entrance or access road.

MEASURING: We will have a VMO on site so all dogs without height cards will have to be measured. We will have a VMO available to measure dogs throughout the day near the trial secretary's table. It is your responsibility to have your dog measured BEFORE you run.

GENERAL: ALL dogs are required to be kept on leash at ALL times. And please pick up after your dogs.

VOLUNTEERS: We will be using the white board for sign-ups. If you can, please volunteer for the class(es) that you can help with. We will issue raffle tickets to each worker to be used in the workers raffle which will have many wonderful items and services. The workers raffle will be drawn at the end of the day. We'll also have food youchers for all workers.

CHECK-IN: Check-in and agility gifts will start at 8am

PRELIMINARY RUNNING ORDER: The Preliminary Running Order is contingent on move-up entries not yet received.

CONFLICTS: We will do our best to accommodate conflicts. Put a "C" instead of a check mark on the gate sheets so the scribe and gate stewards will know you have a conflict.

MOVE-UPS: The deadline for move-ups is Monday, April 16, 2018 at 6 pm and must be submitted in writing (email ok).

VETERINARIAN: Dove Lewis Emergency Animal Hospital is located at 1945 NW Pettygrove, Portland, OR 97209 (503) 228-7281. Directions and maps are available from the trial secretary and will also be posted at the trial site.

HOSPITAL: Southwest Washington Medical Center is located at 3400 Main St., Vancouver, WA 98663 (360) 256-2000, open 24 hours a day. Directions and maps are available from the trial secretary and will also be posted at the trial site.

GENERAL INFORMATION FROM THERESA CALTER:

Sunday there is a horse show in the arena so please don't show up until after 3pm to RV. If you are going to be earlier than that you may be able to use the big parking lot at the front gate or the big parking area at the top of the hill if you use the back gate.

If you want to set up your crate come by Sunday night after 5pm-- you have a better chance of less dust on your stuff and knowing exactly where you can set up for Monday's fun. I hope to have some signs up to help those who don't usually trial here. I will be RVing at the fairground. My cell is 206-355-9205.

GENERAL INFORMATION CONT:

It takes time to prep the surface and the equipment will be coming from another agility trial down south so we will **build the agility courses at 7am Monday**. Many hands make quick work of unpacking and setting up two rings of equipment. Once both rings are built they will be open for walk thru. We have ONLY 4 & 8 jump heights so no adjusting the Aframe or table -YASSSSSS!

We have 117 total agility runs for the day so we could actually be done in mere hours if everyone who can help, does help and exhibitors get to the line in a timely manner. Remember that if the exhibitors are done with walk thru and the first three dogs are ready we do not need to wait for the timer to run down the whole 8 and 5 minutes. That saves A LOT of time when OPEN has only THREE dogs and the average run is less than a minute.

Somewhere we will have lunch and sign-ups for all breed B Match if you are up for it. The B Match will start 30 minutes after the trial is done. It is \$5 for 90 seconds (worker coupon may be used) We use both the STD and JWW Novice courses with 12 weave poles at whatever jump height you would like. More details on this later. Everyone is welcome to participate.

I am planning on having a self- serve Rent a Ring set-up with obedience jumps so Cardi folks can practice for Tuesday Rally and Obedience trial. \$5 for 5 minutes or one worker coupon. Everyone is welcome to participate.
