Holcomb made motion approving the minutes of the January 26, 2017 Meeting. Ryan seconded the motion. Motion approved.

Treasurer Thorpe presented the Treasurer's Report of march 23, 2017. Motion by Braastad, seconded by Davis to approve the report. Motion approved.

Treasurer Thorpe presented the Membership Dues Status Report as of March 6, 2017. No action required/taken.

Steve Peterson, Metropolitan Council, and Paul Czech, MnDOT Metro District presented the findings of the "Principal Arterial Intersection Conversion Study" which was recently concluded. This was a "first of its kind" study that looked at mobility and safety problems at many at-grade intersections on the non-freeway principal arterial system in the Metro Area. 374 intersections were evaluated in Phase I of the study and 91 advanced to Phase II. Of these 91, 34 were designated "High" Priority, 27 "Medium" Priority, and 30 "Low" Priority. 17 Intersections on TH 65 between I-694 and CSAH 22 (Viking Boulevard) were studied. 10 were ranked as High Priority, 3 as Medium Priority, and 4 were ranked as Low Priority. It should be further noted that the study segment "TH 65-B" between US 10 and CSAH 116 (Bunker Lake Boulevard) was one of only two study segments in the entire metro area that had 100% "High" Priority intersections identified. This study is likely to be used as the foundation for future investment decisions in the metro area.

Administrative Representative Fischer discussed the current e-mail distribution list of the Coalition.
