KIFA reserves the right to reject works deemed unsuitable. All entered works must remain on display through the end of the show, with the exception of an out-of-town buyer. Reasonable care will be taken to ensure the safety of your artwork.

KIFA is not liable for loss or damage to artwork. KIFA's commission on all sales is 30%. KIFA reserves the right to use images of the winning artwork for up to eighteen months.
