### **Payment Schedule**

A \$1000 deposit per seat is due at time of booking to confirm your reservation. Remaining balance is due no later than March 3, 2019. (If space is available and a new reservation is received past March 3rd, 2019, the full amount is due at once.)

### **Cancellation Policy - Per Seat**

All cancellations must be in writing. Refunds will be issued less cancellation fees as described below:

- \* Cancellations received up until 100 days prior to the travel date will result in a \$150 cancellation fee.
- \* Cancellations received between 99 days prior to the travel date thru 50 days prior to the travel date will result in a \$300 cancellation fee.
- \* Cancellations received between 49 days prior to the travel date thru 8 days prior to the travel date will result in a \$600 cancellation fee.
- \* No refunds will be issued on cancellations received 8 days or sooner prior to the travel date. Any cancellations received within 8 days of the travel date will result in loss of entire tour deposit/price paid up to that point.

### **Insurance**

Scandi Experience does not provide medical, travelers, trip, or baggage insurance. It is the responsibility of the traveler to obtain this insurance. This insurance is not required, but recommended. Please contact us if you need insurance recommendations.

### **Extensions and/or Deviations**

Not guaranteed but may be available and is subject to additional costs. This is on a first come first served basis, so please contact us as soon as you can if you are interested in an early departure, extending your stay, and/or choosing a different return date.

### **Land Only Package**

If you want to purchase your own airfare and choose your own travel dates you may do so by choosing our Land Only Package at a cost of \$3150. Land Only participants are responsible for any and all transportation/transfer costs required to join and leave the tour itinerary.

### **Baggage Restriction**

In addition to personal items such as purses, laptop bags, and smaller hand bags, each traveler is allowed 1 checked suitcase, and 1 carry-on bag. This is due to cargo space limitations on board our motor coach.

### **Package Price Includes**

International roundtrip airfare from MSP airport. Seat on deluxe tour bus. Double occupancy hotel accommodations with a private bathroom (unless a single occupancy room is requested/needed for an additional fee). Meals, events, and daily excursions as outlined on the itinerary.

**Passport Requirement**

Each traveler must have a passport valid for at least 6 months beyond the return date of the trip. This is a TSA requirement, so please renew your passport early if it expires within 6 months of returning from your trip. Passport fees are the responsibility of the traveler.

**Low Numbers Cancellation and/or Alteration**

This tour requires a minimum number of travelers to register in order for the tour to be executed. Should that minimum number of travelers not be met we reserve the right to cancel the tour due to low numbers. In this case a full refund will be issued for the amount paid up to the point of cancellation. We reserve the right to modify, alter, or substitute, even if for the better, parts of this tour should unforeseen circumstances arise. We will notify you ahead of time if any parts of the tour should change or if the tour will be cancelled due to low numbers.
