The Expo is located south of I-57 exit 308 on Route 45/52. There is ample parking and five entrances. The Expo is indoors; there are fans, no A/C, but typically cooler than outdoor shows on a warm day. Wi-fi available for **sales only**. There is an ATM machine, bathrooms, electric access, and commercial kitchen. All spaces are 10' by 10'. Efforts are made to give returning vendors their same location, but **spaces may need to be changed at the discretion of the coordinator**. New applicants must email photos of their work to

guidelines, available on the Bourbonnais Grove Historical Society's website. Vendors must provide their own tables, chairs, and electrical cords. Monies received from applicants that are not accepted will be refunded. Vendors who are accepted will receive detailed set-up information two weeks prior to the event. This event will be registered with the Illinois Department of Revenue Special Events for the purpose of sales tax collection. Vendors will be given a form and the correct tax rate to facilitate this, and the state will receive vendor contact information for follow-up.

Payment must accompany application. No post-dated checks. Make checks payable to the **Bourbonnais Grove Historical Society**. Please include a self-addressed, stamped, business sized envelope to receive your confirmation and instructions for the fair if you do not have email.
