

## **Annual EEO Public File Report**

Section 3: Supplemental (Non-Vacancy Specific) Recruitment Activities Undertaken by KUTH-Salt Lake City, the station is a small employment unit with 10 full-time permanent employees.

**Internship Program:**

KUTH established an internship program to assist community students acquire skills in broadcasting. During the reporting period, KUTH had three interns; Brigham Young University (Summer, 2015) and Weber State University (Fall, 2015 and Spring, 2016).

**Participated in Job/Career Fairs :**

Davis Applied Technology College Job Fair- on October 15, 2015 Viviane Quintela, Director, Community Empowerment and Marcela Kuck, Office Manager participated at this event. They informed job seekers about job opportunities with Univision and answered student's questions regarding internships.

**Participated in Events Sponsored by Educational Institutions:**

September 21, 2015 Viviane Quintela, Director, Community Empowerment was invited by Real Salt Lake and Utah International Charter School as a guest speaker for the school's "Every Save Makes a Difference" initiative.
