growth and development that would occur in our community.

We have accomplished much this year. We fought against and won the rezoning application of a lot on the corner of Calienta and Gulf Coast that was to be turned into a commercial fishing enterprise and dockage. It would have set a precedent for the adjoining lots to change their zoning as well. We are in the same battle over lots next to the Yacht Club and across the street at the old Gulf Star Marine building. The owners want to turn it into a seafood processing plant with dockage across the street next to the yacht club for large commercial fishing vessels to unload their catch to be processed. It would be a larger industry than what is already done on Calienta street north of Flamingo Blvd and south of the boat ramps. We support our commercial fishing area north of Flamingo Blvd on Calienta Street but we do not support the further expansion of commercial fishing and processing activities into Shoal Line to the detriment of our residential canals and neighborhoods.

Our year end is rapidly approaching and 2017 dues are coming due and payable by the end of this year. I urge everyone to rejoin HBPOA and to get your neighbors and friends who are property owners to join also. There is strength in numbers and HBPOA is the only formally recognized voice representing Hernando Beach to county and state government officials. Join HBPOA and tell us your concerns, ideas, and wishes for Hernando Beach, that is how you can help us to make things happen for the good of your Hernando Beach community.

Motion to accept October minutes as published in November Beachcomber from Cal Holland, Sarge Denby seconded motion.

Treasurers Report – Margo McConnell – Balance on hand is \$6,911.01 in the General Fund. No motion necessary since report is factual.

Margo mentioned the Hernando Beach Vision Statement and proposed a resolution that the HBPOA formally adopt this Vision Statement. This statement has been circulated to the 1100 residents in October and she also had hand out copies for those that wanted them. The County is moving on the Comprehensive Plan rapidly and having our Vision Statement documented will be invaluable in adopting our Hernando Beach environment. This Vision Statement is of purpose and intent. The Vision Plan will be a working document. We want to partner with the County Government, HBPOA and GAC to continue to work together. Margo moved to adopt, Cal Holland seconded the motion.

Gladys reminded all that Hernando Beach is a community and this will give us a formal standing, a voice. The Association and GAC are the communities voice to the issues that affect Hernando Beach. All in favor – answer Aye.

Margo then introduced Diane Greenwell who brought up a “map” or “our dream” and went through things that we are looking to enhance the Beach in the future, such as Sidewalks, Boardwalk, Nature Trails, Trolleys to get folks back and forth to Weeki Wachee, Pine Island, even Walmart. This board is what we call our “Kindergarten Project” so we start from the bottom and work our way up to graduate once all is done. All were encouraged to submit their thoughts, suggestions, ideas on what they might see for Hernando Beach. This is why the board is done in erasable markers so that things can be added, changed or removed. These changes will not only help Hernando Beach but the Hernando County as a whole.

All this is premature and definitely need ideas on what do we want Hernando Beach to become?

Question was made that there were surveyors on Caliente and John Paul Reeve had asked what

was going on and was told they were surveying to widen the lane. Sarge Denby answered by stating that what he knew was the empty lot by parking by boat ramp where single vehicles park would be used to get parking off Caliente. Also there is thought of digging retention pond which would take excess water off of Caliente when raining.

Fran Baird brought up the meeting with SWFMD and that they want to close the parking at this lot which would mean no access in or out, so we need to be aware of all these issues and work closely with these agencies to make sure things of this sort are not done.

Mentioned clearing and moving back forestry and this was done because of concern of fire and spreading should this happen.

Question on what happened to Shoal Line being widened? County was asked to hold off rather than have sidewalks since the sidewalks would not be wide enough for bicycles and should road be widened would just encourage large vessels

to travel down this road.

Gladys mentioned Weedon Island and asked if anyone knew of it. Then told us how great this area was with all the nature and renting of kayaks to go down through the marshes. Something to showcase the community which is what we want in the future for Hernando Beach.

Landscaping Committee – Margo McConnell reported that we received \$5,000 from County for the Triangle – from Grant Program. Question was asked why the watering was so expensive and actually this cost has decreased due to sprinkler system. When having to hand water amount was over \$200 and this has been cut in half. It was stated that now that Garden is put together there is still weeding to do each month and Kathleen Frase is working with the Central High School ROTC to see if they can have 8 to 10 cadets each month come out and weed in order to earn their Community Service Hours. Should this not work we will be requesting volunteers from the residents to give time.

Gladys mentioned her and Cal have been maintaining US19 and weeding there. Takes only about one and half hours for two people and if anyone is interesting in volunteering to contact her or Cal.

Hospitality Committee – Betty McGuire – Planning for Xmas Party which will be December 10th at the VFW on Shoal Line, starting at 7 PM. We pay for meat which is chicken, ham and ask that those attending bring vegetables, side dishes. There will information on Next Door and anyone attending must call Betty or Lucille and give count on how many will attend and what dish they are bringing. Also need to bring a non-perishable item for donation for food drive. If anyone wants to donate an item for 50/50 and raffle call Betty and Lucille and let them know. Cookie Nook got many gift certificates last year for the raffle.

Mentioned that the boat parade was the same day and this cannot be helped because Xmas Party is usually first Saturday of December but the VFW was not available on that date so had to take what we could. People will just have to decide which they want to attend.

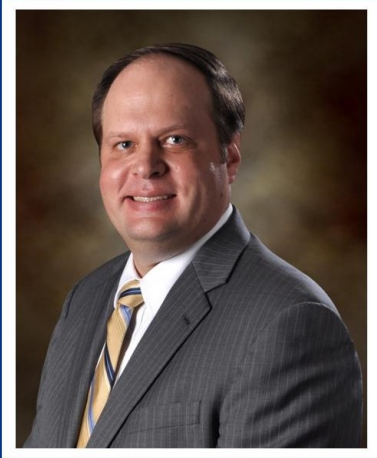

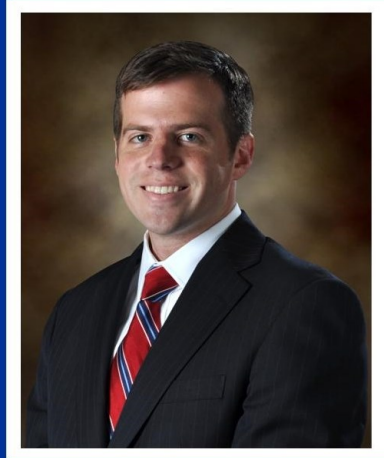

Betty mentioned next year, 2017, she will no longer be doing the 50/50 at the association meeting so if anyone wants to volunteer please let us know. Money from 50/50 goes to Landscaping. Garden is funded from 50/50 and from sale of calendars.

We are going to reorganize the Hospitality Committee and Fran Baird has volunteered to chair that.

Beachcomber – Gladys Moore stated cutoff for December issue is November 10th and if anyone has any articles they have or write to contact Jen know.

GAC – Chuck Greenwell – Chuck informed everyone that there were many important developments that will be happening after the election is over, with the community, fish processing, etc. There will be another community in the future. After the election Hernando Beach will be challenged as to whether it is a seaport or a residential community. Everyone should ask themselves

“what can I do personally to make Hernando Beach better”. We need to unite, build a platform with the County and State Government to keep Hernando Beach a residential community. We are also working with the agencies like SWFMD and with the County. Each agency operates independent of the other agencies and we want to pull these agencies together to gather knowledge on how all this works.

Next Tuesday at the BOCC meeting there will be a second reading on an ordinance which will give our people notices when anything is approached. Gladys Moore as President of HBPOA, Chuck Greenwell – GAC and President from Hernando Beach South will be notified when any application or activity is requested from the County in regards to Hernando Beach so that they can then notify the community.

Suggest that all go to BOCC site and look at agendas and agenda packages. Diane Greenwell monitors all the time and goes through numerous pages each time. Just want to encourage everyone to be aware of all going on and at-

Director Position had 2 openings and 3 nominees so a secret ballot was held, community given ballots and asked to choose 2 people. Ballots gathered and counted and two Directors chosen. 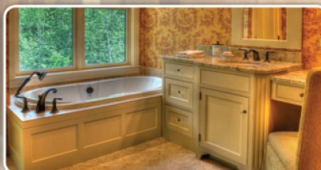

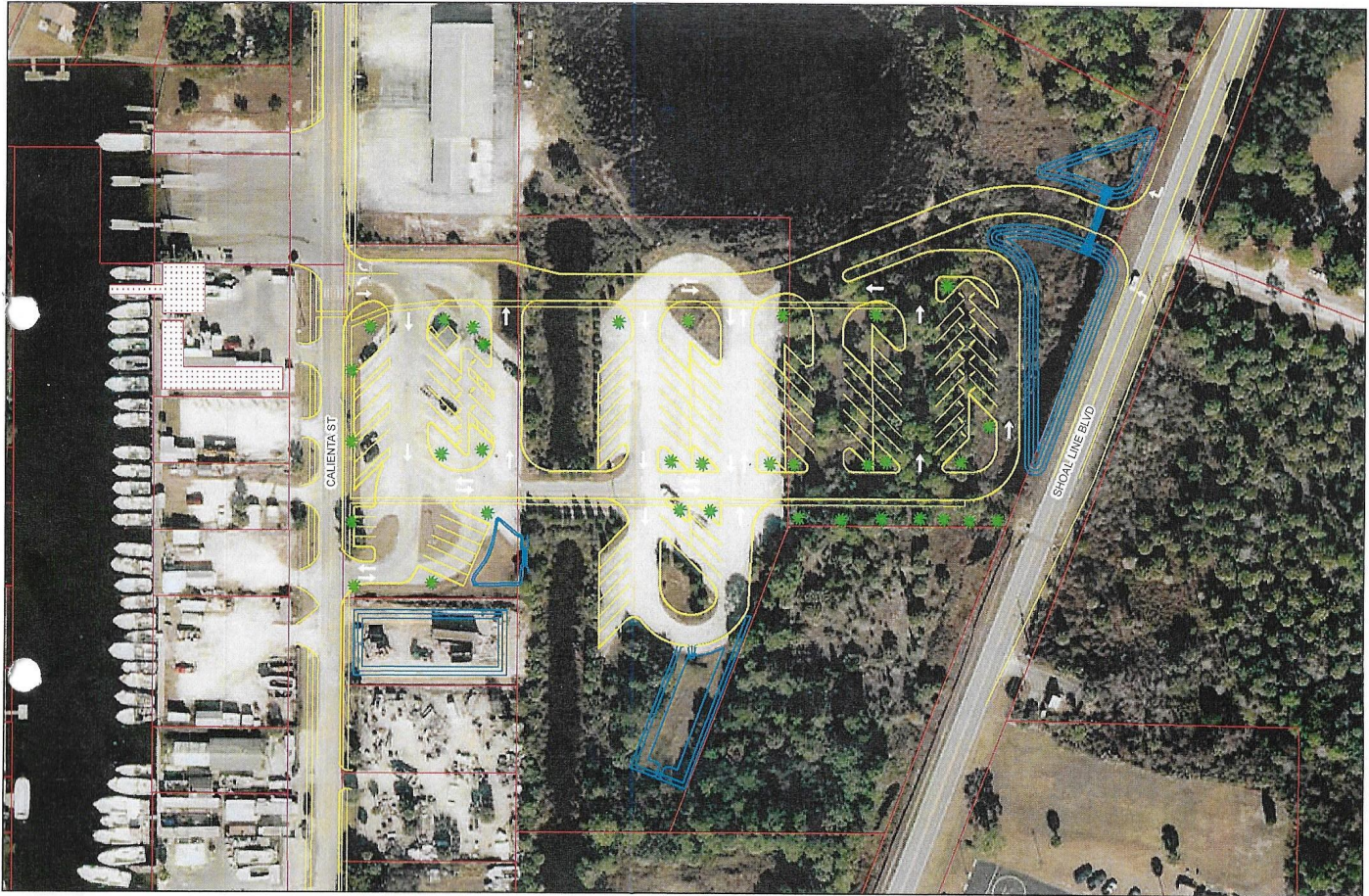

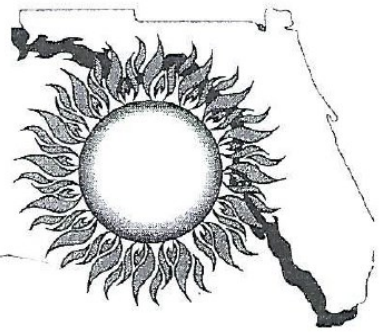

WHAT IS CRIME WATCH?



A neighborhood watch, also called crime watch, is an organized group of civilians devoted to crime and vandalism prevention within a neighborhood, according to Wikipedia. In other words, crime watch is a crime prevention organization under which civilians agree together to keep an eye on one another's properties, patrol the street, and report suspicious incidents to law enforcement.

The aim of crime watch includes educating residents of a community on security and safety and achieving safe and secure neighborhoods. Our Crime Watch is organized as its community association, with Articles

of Incorporation and Bylaws.

Neighborhood watches are not vigilante organizations. When suspecting criminal activities, members are encouraged to contact authorities and not to intervene.

The current American system of neighborhood watches began developing in the late 1960s as a response to the rape and murder of Kitty Genovese in Queens, New York. Some local civilians formed groups to watch over their neighborhoods and to look out for any suspicious activity in their areas. Shortly thereafter, the National Sheriffs' Association began a concerted effort in 1972 to revitalize the "watch group" effort nationwide.^[1]

The neighborhood watch system gained intense media attention after the February, 2012, fatal shooting of teenager, Trayvon Martin in Sanford, Florida by George Zimmerman, an appointed neighborhood watch coordinator.^[2] His actions on the night of the shooting generated controversy as he exited his vehicle and was carrying a gun, both of which go against neighborhood watch recommendations.^[3]

A June 2012 *New York Times* article reported that neighborhood watches in the New York City area are growing again after decades of decrease due to
