IMPORTANT Applications will not be processed without the application fee of **\$2500**. Please make checks payable to "US MARSHALS POSSE". If you do not meet the criteria for membership, **\$2,000** will be refunded. The application fee includes the first year's dues, two USMP badges, a wallet with identification credentials, a USMP hat pin, belt badge holder, a USMP belt buckle for our western uniform, polo shirt with USMP logo, dress shirt with USMP logo. A current passport style photograph must be attached with this application. • ARTICLE I - Section XI MEMBER PARTICIPATION As of June 10, 2015, all current and new posse members will be required to participate in a minimum number of sponsored events each year including: one (1) General Membership Meeting; three (3) parades; and one (1) sponsored function. To encourage member participation in these activities, the USMP Board has established fees for failing to meet the mandatory participation requirements. These fees when applicable will be added to the annual dues of \$200 for the following year. Missing both General Membership Meetings in one year will result in \$75 fee; failing to participate in (3) parades will result in a \$75 fee per parade; and non-participation in (1) sponsored function will result in a \$75 fee. The total of all non-participation fees for mandatory activities and will not exceed \$300. When applicable, these fees will be in addition to the annual dues of \$200. • ARTICLE I - Section XII UNIFORM All active members and other members participating in sanctioned functions shall own a uniform as defined by the Uniform Committee. the official uniform of the Posse shall consist of the western hat with badge pin, white western cut, long sleeved shirt, black cloth tie, black leather vest with official badge, black wrangler dress pants, black western boots, black belt and Marshal buckle and leather gear with holster and revolver. This attire shall be known as the Class "A" uniform. It is recognized that black shoes other than the western boot may be worn by the non-rider at official functions, particularly parades. Any clothing worn at certain functions other than described above shall be known as the Class "B" uniform shall be limited to events other than major, official functions and shall be with the authorization of the Posse President or his designated representative. No member of Posse shall appear in public in a Class "A or Class "B" uniform unless the appearance is related to an official Posse function. Applicant agrees to return all badges and buckles to the Posse upon resignation or removal from the US Marshals Posse. Applicant understands there will be charge for these items if not returned in 30 days. Background check may be waived if a valid, current copy of your Concealed Carry Weapons ID card is submitted with your membership application form.
