MICHAEL BICKELMEYER INTERVIEW WHK 1420 AM SEPTEMBER 27, 2015 8:00 PM EASTERN

We've been waiting so long, We've been waiting so long, We've been waiting for our son to rise and shine.

Shining still, to give us the will.

Can you hear me, the sound of my voice?

I am here to tell you, I have made my choice.

I've been listening to what's been going down.

There's just too much talk and gossip going 'round.

Somehow, some day, we need Just One Victory and were on our way.

Prayin for it all day and fightin for it all night.

Give us just one victory, it will be all right.

You just call lonely Brother when you need a hand.
We all need, somebody, to lean on.
I just might have a question that you'll understand.
We all need, somebody, to lean on.

Thank you for having me on air tonight Mr. Phillips am very happy to speak this evening. Yes Sir, I am running for the Office of President Of The United States Of America as a Republican in our 2016 Election.

I have 40+ years of work experience in the private sector, whereby I have labored in business, commerce, and industry. I have earned all of my education here in the Cleveland, Ohio area. I am a 1977 graduate of the City Of Parma School System. I earned my Associate of Arts Degree from Cuyahoga Community College 1985. I earned my Bachelor Of Science Degree, in General Business Administration from David N. Myers College 1996. I then graduated from Security Academy at Cuyahoga Community College 1999. I went on and earned my Master Of Management Degree from the University Of Phoenix Online 2013.

I believe that I am bringing things to the table for our 320 million United States of America population that no other Presidential Candidate in our Nation's history ever has, from any active or inactive political party in our Country. Because the airport and industrial facility is powered by clean energy generation there are zero carbon emissions, zero greenhouse gases, and zero global warming affects.

My second form of intellectual property is a federal grant application project, employer identification number 01 - 0572298 with the United States Department of Agriculture in Columbus, Ohio. This industrial project is designed to be a recycling facility also powered entirely by clean energy generation. This industrial facility utilizes the same forms of clean energy generation as the airport system. They are solar collectors, wind power generators, hydrogen fuel cells, geothermal power generators, solid oxide fuel cell generators, biomass power generators, magnetic power generators, hydrogen electrolysis generators, and hydrogen fusion power generators.

Once again because the industrial facility is powered by clean energy generation, there are zero carbon emissions, zero greenhouse gases, and zero global warming

affects. The design of this industrial facility is comprised of a 300' x 900' building housing five industrial furnaces for smelting. Each furnace is designed to hold 100,000 pounds of product.

The potential combination of the airport system and the recycling facilities can entail glass, plastic, aluminum, copper, and steel as designated to their each and own separate industrial facilities. This brings to the table for America including the airport system, at minimum six facilities per state for a minimum of 300 facilities or applications across our Country.

My third form of intellectual property is a weapon system I have titled a gift for children. This application is also at our United States Patent Office. The application number is 14726657.

This invention, the substance and idea is an innovation designed specifically to ensure for the children of today a safe, and secure tomorrow. A device designed to keep families together without separation. This invention is designed for pest control elimination. This device when used, can ensure a clean pollution free environment, without any radioactive nuclear fallout. It can be remote activated from any location. This invention is created to protect, watch, and guard the free world. It is designed for the development and use by the United States of America for the primary protection of those that prefer the confidence of safety, and security. The function is to aid with the war on terrorism and drugs. This innovation is a defense system.

The using of this invention is the magnification of sunrays from a point and external from the earth, to erase from the world the spirits of dread, nightmare, and utilize pest-control. Sunrays are directed to the aft, farthest from Earth by reflective transfer and combination of reflective transfer combination relays, from a series of locations around the earth. These transfers of sunrays are from the sun. This innovation is a technological advance in warfare defense systems.
