PRIZE MONEY AND AWARDS

Prize ratio will be at least one for every three entrants. Bowlers who earn prize money in the SPSS will be paid in cash. In addition to the prize money, tournament champions will receive symbolic awards. Prize winnings will be distributed from the casino Cashier's Cage, and should be available 1 hour after the tournament conclusion. Prize winnings that are not distributed will be mailed to participants within 30 days of the conclusion of the tournament. If for any reason a bowler wishes to waive the prize money, it is that bowler's responsibility to notify tournament staff in writing, at time of registration regarding their refusal of the prize money. If the prize money is waived, the amount will be returned to the prize fund for distribution.

The IRS requires SPSS to furnish 1099 forms to individuals who accumulate winnings of \$600 or more annually in any SPSS event. Therefore, social security numbers must be provided per by IRS regulations. Failure to provide a social security number (U.S. citizens) or an Individual Tax ID Number-ITIN (Non-US citizens) to SPSS will result in a 30% tax reduction of the prize winnings.

CONDUCT

All tournament bowlers shall conduct themselves in a professional manner at all times while in the host center or on the property of the host center and on social media before, during, and after the event. Any criticism by a tournament bowler who discusses the sponsor, host center or personnel, lane conditions or pins, SPSS or its staff, or their fellow competitors in an unfavorable manner or who otherwise engages in actions unbecoming a SPSS bowler in the opinion of the Tournament Director shall be in violation of the Code of Conduct. Unsportsmanlike behavior will not be tolerated on the lanes or inside the tournament venue. Individuals are subject to ejection for engaging in improper tactics or conduct including, but not limited to, physical and verbal abuse toward another person. Anyone found to be in violation of the Code of Conduct will be fined and may be refused entry to the event or disqualified from the competition in which the violation occurred and/or declared ineligible for future competitions.

Penalty: *First offense: \$250; Second offense: \$500; Third offense; \$1,000*

Electronic Media: The SPSS regards electronic media such as message boards, conversation pages, and other forms of social networking (such as Facebook and Twitter) as important tools of communication and fan interaction. Tournament participants may not use these platforms to defame or otherwise attack the integrity of the SPSS, its members, staff, sponsors, host center, or host center employees.

DRESS CODE

A shirt with the participant's name on the back is required for the SPSS Championship. A named short is not required but strongly encouraged for other SPSS events. Name lettering must be at least two inches in height. Paper name plaques are not acceptable. Men must wear dress slacks.

Women must wear dress slacks, skirts, or skorts. Examples of prohibited attire include but are not limited to:

- Tank tops, halter tops, bare midriffs, spaghetti strap tops, hats (medical reason only), etc.
- Workout attire, t-shirts, shorts, short skirts, bib overalls;
- Cords, jeans, or any kind of denim

EATING, DRINKING, and SMOKING

Entrants are NOT permitted to smoke or drink alcoholic beverages while participating in this event. This includes from the start of practice to the last ball thrown for score in qualifying, match play, and finals. Bowlers are permitted to eat a small snack (ex: power bars, candy bars, fruit) during competition.

Senior Shootout Eligibility

The South Point Senior Shootout (SPSS) is open to all bowlers age fifty (50) and over as of November 13, 2016, in good standing with the United States Bowling Congress (USBC), and with fewer than three (3) PBA and/or PBA50/Senior PBA National Event titles. Bowlers age 63 and over as of November 13, 2016 may enter regardless of the number of PBA or PBA50/Senior PBA National Event titles.

Senior Shootout Cost

The total cost to enter the South Point Senior Shootout (including the SPSS Championship) is \$750.00. The total fee (\$750.00) must be paid in full prior to the start of competition to be eligible for the SPSS Championship. There is no extra cost to the bowlers qualifying for the SPSS Championship. Bowlers may enter one or more of the three one-day challenges for \$200.00 each. Bowlers entering the challenge(s) individually at the \$200 rate will not qualify for the SPSS Championship. Entry into the SPSS Championship must be earned and cannot be purchased. Entries will be taken until 8:00 AM, Monday November 14 or until the field is full, whichever occurs first. Entry priority will be given to bowlers paying the full \$750 entry over bowlers entering Challenge events individually. The Shootout is limited to 140 entries.

Senior Shootout Event Formats

Turbo Challenge

Qualifying: Six games across twelve lanes on a 35' pattern. One in three plus the top four Super Seniors (age 60 and over) below the cut line advance. Qualifying Leader (or leaders in the event of a tie for Qualifying Leader) is/are automatically seeded into Stepladder Finals.

Cashers' Round: Drop all pins. No re-oil. Advancing bowlers (including the Qualifying Leader(s)) bowl four games across eight lanes. Top five advance to Stepladder Finals. If the Qualifying Leader(s) is/are not in the top five after completion of the Cashers' Round, that bowler(s) will be seeded respectively in the lowest positions for the Stepladder Finals and the remaining Stepladder spots will be filled from the Cashers' Round.

Stepladder Finals: Single game elimination with 5th place bowling 4th place; winner bowling 3rd place, etc. If the Qualifying Leader is also the Cashers' Round leader, that bowler must be defeated twice in the Stepladder.

Logo Infusion Challenge

Qualifying: Six games across twelve lanes on a 39' pattern. Top 14 plus the top 2 Super Seniors advance. If two or more Super Seniors are in the top 16 qualifying totals, then the top 16 advance. Drop all pins. Re-oil lanes.

Bracket Round 1: The 16 qualifiers compete in a seeded (1 vs 16, 2 vs 15, etc.) best-of-five one-game match. Eight winners advance.

Bracket Round 2: Winners from Bracket Round 1 compete in a best-of-three one-game match. Four winners advance.

Bracket Round 3: Winners from Bracket Round 2 compete in a one-game match. Two winners advance. ®

Bracket Round 4: Winners from Bracket Round 3 compete in a one-game match. Round 4 match winner is the Logo Infusion Challenge champion.

Haynes Bowling Supply Challenge

Qualifying: Six games across twelve lanes on a 43' pattern. The top 20 qualifiers plus 4 Super Seniors (with less than 96 entries), top 26 plus 6 Super Seniors (with 97 to 119 entries), or top 32 plus 8 Super Seniors (with more than 119 entries) advance to Match Play.

Match Play: Qualifying pins carry over. No re-oil. 5-game Modified Match Play with 30 bonus pins added to each single game victory (15 bonus pins for ties). In each match, the higher seed will decide which bowler starts the match on the left lane. Fifth Round is position round. Top five advance to Stepladder Finals.

Stepladder Finals: Single game elimination with 5th place bowling 4th place; winner bowling 3rd place, etc.

South Point Senior Shootout Championship

The top twenty-four bowlers as determined by their **qualifying positions** from the three previous events earn a spot in the SPSS Championship. All qualifying pinfall is dropped. The 43' pattern will be on the left lane of each pair and the 35' pattern will be on the right lane of each pair.

Round 1: Eight-game Match Play with 30 bonus pins added to each single game victory.

Round 2: Eight-game Match Play with 30 bonus pins added to each single game victory.

Round 3: Eight-game Match Play with 30 bonus pins added to each single game victory. Final game is Position Round. Top five after 24 Match Play games advance to Stepladder Finals.

Stepladder Finals: Single game elimination with 5th place bowling 4th place; winner bowling 3rd place, etc. The Shootout Championship leader after 24 match play games must be defeated twice.

The entrant whose name appears hereon or my authorized replacement hereby agrees that the SPSS, its officers and agents shall be liable only to the extent of returning entry fees, less expenses, if and when that entrant shall be prevented from bowling any event in the tournament through premature termination of the tournament, which may be brought about by war, national emergency, or emergencies or causes relating thereto resulting therefrom, fires, labor difficulties, terrorism or threats of terrorism, or other causes beyond the control of SPSS. I further agree that SPSS may use my name and likenesses (including video) for promotional purposes at no cost to me and with no fees being paid to me.
