## **CERF (Canine Eye Registration Foundation)**

**Dedicated to the elimination of heritable eye diseases in purebred dogs through registration and research.**

**The Canine Eye Registration Foundation was formed by a group of purebred dogs owners with the intention of identifying and recording inherited eye diseases. They realized the direct effect that these diseases had on the quality of the affected dogs lives and wanted the means to eventually eliminate these diseases from the affected breeds. This dedicated group of breeders enlisted the cooperation of the American College of Veterinary Ophthalmologist (ACVO) and their board certified members to perform the eye exams to ensure uniformity of the actual exam and the recording of their findings in a centralized, national registry.**

**The CERF Registry not only registers those dogs found to be free of heritable genetic eye disease but also collects data on all dogs examined by A.C.V.O. Diplomates. This data is used to form the CERF database which is useful in researching trends in eye disease and breed susceptibility. This data is made available to not only researchers and veterinary clinicians but to breed clubs, breeders and interested individuals and owners of specific dog breeds.**

**The CERF exam is painless. Drops are instilled into both eyes to cause pupil dilation to aid in the exam. Some breeds will need to be examined prior to having their eyes dilated to detect diseases hidden when the pupils are dilated. After completing their exam, the Ophthalmologist completes the CERF form and denotes any**

specific disease(s) found. If the dog is found to be free of heritable eye disease it can be entered into the CERF Registry. The completed owners copy of the exam report is sent into CERF. A CERF number will be issued which is good for one year from the date of the exam.

In order to receive a CERF number the dog has to have a permanent form of identification such as a microchip, tattoo or DNA profile. After one year, the dog must be reexamined to maintain its' registration with CERF. Regardless of the outcome of the dog's exam, the research copy of the CERF form is sent to CERF office at Veterinary Medical Database where its information will be entered into the database for that specific breed. This information will be used to generate research reports but the individual dog's identity remains confidential and is never released.

As Pequeno owners and breeders we are in an enviable position. We have the chance to test ALL of our breeding stock as well as ALL of their offspring to help identify IF the breed does have a genetic eye disease(s) and to monitor the incidence of said disease(s) and work with genetics Committee of the A.C.V.O. to formulate effective breeding plans to either eliminate the disease(s) completely or to significantly reduce the incidence of said disease(s). If no heritable genetic eye disease(s) is found, by continuing to CERF our dogs we'll be able to monitor the Pequeno population to make sure it remains disease free. Very few other breeds have this incredible opportunity to be so proactive in regards to heritable eye disease in their foundation stock. By CERFing EVERY Pequeno we can do our part to help insure that our beloved breed is as healthy as possible in regards to their vision and embrace CERF's stated goal to eliminate heritable eye disease in our purebred dogs – our Pequenos.

Judge's Critique

Patricia H. Gilbert – judge AKC#20340

Thank you to the Portuguese Podengo Pequeno of America for inviting me to judge this match. I enjoyed the entry, hospitality and the opportunity to discuss the future of the breed and to discuss and demonstrate a natural style of grooming your breed.

Many of the exhibitors are very familiar with the American Kennel Club shows and their exhibition. I believe that in this aspect your club has an advantage over other rare breed organizations. You already understand the requirement for table training, complete body and dentition examinations, and gaiting on loose leads. You understand the rules and requirements to make up a champion in the AKC system. Your paperwork, timeliness, sportsmanship, and deportment will be assets to AKC.

The Portuguese Podengo Pequeno is truly a rare breed and while my entry was small at 9 dogs (4 bitch puppies, 1 open dog, 4 open bitches), the entry was filled with quality and excellent breed type. All dogs were presented in very good to excellent condition for weight and muscle tone.

Every dog was easily identifiable as a Portuguese Podengo Pequeno. I did see three distinct styles ranging from the very light to the heavier end of the Breed Standard portion for the Pequeno. I had no smooth coats exhibited. They were all rough or wire coated. I found that even in the puppies, the texture was acceptable and none were overly soft. Facial furnishings were quite good as well. Color was true to standard with shades of yellow and fawn with white markings.

I found general outlines to be acceptable with body proportions being longer than tall. Necks and heads for the most part in profile were also very pleasing and correct.

The heads of my exhibits were varying in degrees from exquisitely wedged shaped with pointed muzzles to simply lean heads. Some backskulls were correctly flat and some were a little too domed. I had three heads with divergent planes and they were my top awards.

I believe the ears and expression are the Hallmarks of the breed. All but one exhibit had properly tall ears. Where there was a lot of difference was in the set on which should be medium and not too high and in the shape of the base which should be wide. All had mobile ears.

Eye shapes were from round to almond which is preferred. All exhibits had correct eye color. All eyes sparkled but some were livelier than others.

Pigment was very good to excellent. Only one exhibit has missing pigment but had other qualities.

Dentition and bites were acceptable. All were scissor bites with the exception of one that was slightly overshot.

Necks were well made and only one was not truly correct and too short.

All toplines but one were fairly level standing and on the move. Rib cages were long enough with a long sternum bone for bottom rib attachment. Only one exhibit had a shorter sternum bone ending at the elbows. Tuck ups were slight with the exception of the short rib caged hound. All loins had degrees of strength from strong to power packed.

Tail sets were from correctly moderate to very high set. All tail sets corresponded in carriage and attitude on the move. They ranged from a nice saber to much too tight and over the back. Length of tails was

good with only one short tail that did not reach the hock. There were two tails with kinks at the ends.

Fronts were in varying degrees from well made and laid on to very upright and set on too far forward. There were degrees of straight legs to some very crooked legs and out at the elbows.

Rears were all quite good, muscled and moderately angled.

Feet both front and rear of all exhibits were almost oval to truly oval with fairly strong pads. Toenails on several exhibits were too long and distorted the true shape of the foot.

Movement and side gait with two exceptions was light footed and agile. This is a little hunting Sighthound and because he is I like to see a tendency to converge both front and rear at the trot as speed increases.

Had I one Best in Match overall, it would have been my Best Puppy in Match. She was a little feminine yet strong bitch that had it all. She had the best classic chiseled and shaped head with divergent planes and flat backskull. Her almond eyes absolutely sparkled and shone with curiosity. She had the best medium ear set and ears with a wide base and triangular shape. She had the best mobility of ears of the entire entry. Her body and carriage were perfection. She was refined and feminine without being delicate. Her movement was very clean going and coming. She had the best side gait with a quickness and lightness of movement. She was a big Sighthound in a little package and she told the world that she was. She thought she was all that and a bag of chips.

My Best Adult in Match was the only male. He was at the top end of the Standard for size and weight but he had a lot to offer. He was masculine. He had a strength of body, prosternum and rib cage that is needed in a hunting hound. His topline and loin were rock solid and muscled. He had excellent balance of angulation in front and rear. He had tight oval feet. On the move he too exhibited the required lightness and cleanness of movement. His rough coat was in transition but had enough correct and harsh texture. He had a proper lively temperament. He was pushed very hard for the win by my Best Adult Bitch.

She was in the mid range for size and weight. She was very feminine. She had a lovely head shape and tall ear. Her body was strong and sighthoundy. She had good balance between front and rear both standing and on the move. Her coat was properly textured.

Where she lacked and lost to the male was in her attitude and carriage. It was clear that she was new to the ring and unsure of her surroundings. Had she been more experienced, she would have taken the win over the male.

We can think about potential but, we can only judge what we have and see on the day.

I believe this group of Portuguese Podengo Pequeno people and their little hounds are doing well by and for their breed. I know they will be an asset to the American Kennel Club once they gain final recognition.

Thank you again so much for the privilege of judging your wonderful little hound breed.
