CAN LA INFRASTRUCTURE KEEP PACE WITH HOUSING GROWTH?

RANDALL WINSTON, LA DEPUTY MAYOR FOR INFRASTRUCTURE EXPLAINS THE FUTURE



- How do we expand to meet water, power, and sanitation demands of massive new housing?
- Who fixes our streets and potholes and when?
- Where are people in new apartments with no parking supposed to safely park their cars?
- Who controls Metro and how do they get away with blatantly ignoring the public?

Randall Winston is Harvard educated, an architect, and an attorney – and today is LA's Deputy Mayor for Infrastructure. He reports directly to Mayor Bass and is responsible for developing infrastructure policy and aligning public works and transportation invest-

ments – a terrifically complicated challenge covering LADWP, LADOT, street services, sanitation, and even Metro.

Randall was an attorney at O'Melveny & Myers, where he represented government and environmental organizations facing complex litigation and state and federal investigations. He previously served as Executive Director of the California Strategic Growth Council under Governor Jerry Brown, overseeing investments of more than \$1.3 billion in transit-oriented affordable housing and land conservation. Before that, he worked for Pritzker Prize-winning architect Norman Foster, collaborating with interdisciplinary teams on design, urban planning, and infrastructure projects throughout the world. He spent two years working with urban development and architecture firms in Beijing, China.

SHOULD IT BE ILLEGAL TO SLEEP ON THE STREET? THE GRANT'S PASS DECISION

This last week the Supreme Court of the United States heard arguments in what may be a landmark case in the battle to regulate homelessness. The case of City of Grant's Pass (Oregon) v. Johnson will likely have a significant impact on the homelessness challenge in cities across the western United States. The court could overrule the seminal case of Martin v. Boise (Idaho) which ruled that the city cannot enforce restrictions on "public camping" – sleeping on the street – unless it also provides the homeless with a place to go (like adequate temporary shelter). The Boise case is currently the law of the land in California, and it serves to tie the hands of cities seeking to enforce their health and safety laws – elevating the rights of the homeless above the rights of the community.

Opposition against Grant's Pass: Those who are opposed to permitting cities to fine the homeless characterize the issue in many ways. Does a city have the right to "punish" someone for sleeping outside? Should the homeless be a "protected class" and therefore not treated as criminals simply for "being homeless"? Should a city not be able to remove or fine the homeless unless there are adequate shelter beds? If the Supreme Court rules that it's not a violation of the 8th amendment to the US Constitution, they will make the problem much worse than it is now by pushing the homeless from point "A" to point "B" with no solution to the problem. And the imposition of stiff fines and even jail time for the homeless constitutes "cruel and unusual punishment" because many are homeless due to no "fault" of their own. It would literally make poverty a crime.

Support in Favor of Grant's Pass: Those in favor of the law under review in Grant's Pass see it this way. Cities must have the right to enforce basic laws that supporting a constitutional right to sleep in the street simply tramples. This situation has gotten out of control with the rights of the homeless seriously infringing on the rights of local citizens and businesses, as well as the city, who expect basic health and safety laws to be enforced – such as: you cannot use my storefront or front lawn as a toilet; you can't do drugs and pass out in my cul-de-sac; and you can't build a tent city on my corner. Something needs to be done to help the homeless and we support that. But, regardless of what alternatives are available or not available for the homeless to sleep somewhere else, they can't sleep here (insert homes, businesses, public transport, or parks).

A decision from the Supreme Court is expected sometime in late June. Its issuance will have a significant impact on the degree cities can regulate and punish the homeless. But one thing is certain – whatever the ruling, it will not solve the homeless crisis in America.

SB9 DECLARED UNCONSTITUTIONAL - FOR NOW

SB9, the state law that ended single-family zoning by allowing four homes to be built on a single-family lot or allowing a single-family lot to be split in half with two housing units on each half, has been declared unconstitutional in Los Angeles County. SOHA opposed SB9 because it was presented as a bill that addressed our affordable housing problem but none of the units built under SB9 were required to be affordable. We always felt this was a bill created more to benefit developers than homeowners.

The bill caused controversy because the state claimed that affordable housing was a statewide concern and, as a result, the state could overrule any city's land use laws. In California we have 121 charter cities and Los Angeles is one of them. Charter cities have their own charter that grants them constitutional right to govern their own municipal affairs. Land use is considered a municipal affair. Cities fought against the loss of this local land-use control when SB9 was introduced. The bill ultimately was passed in the legislature and became law in 2021.

On April 22, the Superior Court in Los Angeles ruled SB9 unconstitutional, granting a victory for a case brought by the City of Redondo Beach vs Attorney General Rob Bonta. In the ruling the lawyers for Redondo Beach argued that the premise of SB9 was neither reasonably related to its stated concern of ensuring access to affordable housing nor narrowly tailored to avoid interference with a local government's right to determine its own land use laws.

The court stated that the State of California "presented no evidence to support the assertion that the upzoning permitted by SB9 would result in any increase in supply of below-market-rate housing." The court concluded that "SB 9 is therefore unconstitutional as violative of the home rule doctrine."

This ruling will certainly be challenged by the State of California. The ruling currently applies only to charter cities but has tremendous potential impact. If this ruling is upheld, a charter city that allows SB9 could be sued by individuals objecting to its application. WE WILL KEEP YOU INFORMED AS THIS CASE MOVES FORWARD.

METRO STILL REFUSING TO TELL PUBLIC REAL FACTS ABOUT SEPULVEDA PASS TRANSIT PROJECT

For eight years, SOHA has been trying to work with Metro to get the best Sepulveda Pass Transit project for our community, the city, and the county. We made comments. We attended Metro public meetings. We met with elected officials. We met with Metro. We asked for information. But Metro kept stonewalling us and saying it's coming, just wait. We're through waiting. We're working with other organizations, including Keep Bel-Air Beautiful, to learn what we should have known all along about the project. Here's where we are today.

In late 2022, Keep Bel-Air Beautiful made a request to Metro pursuant to the California Public Records Act to obtain various documents about the Sepulveda Pass Transit Project, its budget, and its public outreach efforts. Unsurprisingly, Metro was not forthcoming with documents, so Bel-Air has now brought legal action to force Metro to comply. Through this action, Bel-Air aims to enforce the public's right to obtain public documents and pierce the veil of secrecy that Metro hides its operations and deliberations behind. The final court hearing in Bel-Air's action is set for August of this year. Bel-Air is optimistic that the court will see through Metro's excuses for keeping documents from the public and force Metro to comply with the law. We'll keep you posted.

Last month, SOHA submitted 20 critical questions to Metro CEO Stephanie Wiggins who responded with 19 unacceptable answers. Metro's answers to SOHA's questions were so off the wall that a friend suggested I publish them as a weekly series in CityWatch Los Angeles (www.CityWatchLA.com). HUGE LOOPHOLE FOR FAITH-BASED ORGANIZATIONS

The LA Planning Department is proposing a housing program that would allow Faith-Based Organizations to build affordable housing on any land they own. This is not a new concept. It is actually based on Senate Bill 4 that became law in January 2024. California law allows Faith-Based Organizations to develop affordable housing on underutilized land they own anywhere, even in single-family neighborhoods. Faith-Based Organizations often inherit land they don't need, and this law makes it less restrictive for them to build housing on it. The state passed SB4 but added one important criterion – these underutilized properties had to be owned prior to January 2024.

LA Planning Department's current proposal is to remove the "time-of-ownership" criterion to make the program more flexible. This would now allow any property newly purchased by a Faith-Based Organization, even in single-family neighborhoods, to get fast-track approval with no public input.

We think this opens up a huge loophole that developers will take advantage of. By partnering with any Faith-Based Organization they then have full access to single-family neighborhoods. Currently, developers are not granted the right to build apartments in single-family neighborhoods. This program is ripe for abuse.

We are meeting with the Planning Department, Councilmember Raman's Planning Deputy, and the Mayor's office to express our concern and that of numerous other communities. While we certainly don't object to Faith-Based Organizations building affordable housing, we do object to the city making them land speculators with full and unaccountable access to our neighborhoods.
