

## July 24 Update

**CDFA Hearing Decision:** As a result of last week's decision by CDFA Secretary Karen Ross to increase the whey value in the 4b price, the gap between California prices and federal order prices will decrease in August. In July the gap between the California Overbase price and federal order prices based on California utilization totaled \$1.07 per cwt. In August that gap, again based on California milk utilization, will shrink to 46 cents per cwt. It is important to recognize that the recent decision to increase the whey value in the 4b price will only continue for one year.

In a letter to the industry sent when the hearing decision was announced, Secretary Ross stated, "California's system of regulated milk pricing is antiquated and outdated. Our industry competes within national and international markets that have dramatically changed since our pricing system was established. Our pricing system needs to be updated to provide the opportunity for our dairy families and processors to achieve long-term growth and prosperity. I believe, as stated in the past, that we must work together to find long-term solutions to address the issues affecting our Califomia dairy industry. Later this year I will contact members of our industry with the purpose of meeting together to collaboratively work towards implementing appropriate reforms to our pricing system."

Given the likely push for additional stakeholder meetings to "update" the pricing system it is important to recognize the strong justification for milk regulation in the current California Food and Agriculture Code. Section 62700-6273 states, "...unfair, unjust, destructive and demoralizing trade practices have appeared within this industry and these practices constitute a menace to the health and welfare of the inhabitants of this state by threatening the stability of this industry..." Under federal order regulations, **dairy producers have the right to vote** when changes or "updates" are made to federal milk marketing orders. CDC welcomed the decision to increase the whey value in the 4b formula; however, the only long-term solution to make dairy pricing in California more equitable is by joining the federal milk marketing order system.

**Country-of-origin labeling (COOL):** CDC and California Farmers Union sent letters to Senators Feinstein and Boxer urging their support for mandatory country of origin labeling. This week, Senators Stabenow, D-Mich., and Hoeven, R-N.D., introduced voluntary country of origin labeling legislation and Senator Pat Roberts, R-Kan., introduced legislation for full repeal of meat labeling.
