The Edward and Shirley Calahan Scholarship

The Calahan Foundation, an Illinois 501(c)(3), has established the Edward and Shirley Calahan Scholarship Fund. The goal is to aid students who demonstrate excellence in education and a financial need.

Each year four (4) new scholars are awarded \$5,000.00 payable over a 4-year period. To qualify the applicant must be a 2019 - 2020 graduating high school senior who has demonstrated academic excellence (minimum G.P.A. 3.0) and a financial need. A letter of acceptance to a 4-year university or college is required. All applicants must live within Cook County in Illinois. The first distribution of \$2,000.00 is paid after the scholar's first semester. Funds are awarded upon the student maintaining a 2.5 G.P.A. and submitting an official copy of their fall semester transcript. The scholar should expect to receive payment at his/her institution by the end of January. All subsequent distributions of \$1,000.00 over the next 3 years, have the same requirements as the 1st distribution.

Students who receive scholarships are also inducted into the Calahan League of College Scholars (CLoCS) Mentor Program. Our mentoring program extends our reach further into the lives of our scholars. The CLoCS Mentor Program prepares new scholars to successfully transition into college through workshops and persist to graduation and beyond.. All scholarship recipients are expected to attend our monthly virtual mentor video sessions. All scholarship recipients will also be required to attend our Annual Induction Ceremony, which will be held on Tuesday, July 14, 2020 at 6:00 pm at the foundation headquarters.

Scholars are also encouraged to attend as many of the following events as possible:

Hadiya Pendleton "Stop the Violence" Scholarship

The Hadiya Pendleton "Stop the Violence" Scholarship was created in memory of Hadiya Pendleton. She was tragically shot and killed while standing with friends inside Harsh Park in Kenwood community of Chicago. As a student at King College Prep High School, she was killed only one week after performing at events for President Barack Obama's second inauguration.
