AFICS-Cyprus: Third Annual General Meeting

The AFICS Cyprus Third Ordinary Assembly Meeting, held on 10 March, was attended by 39 members. With nine items on the agenda, the meeting covered an extensive number of subjects and, following the report of the President, the floor was opened for discussion.

One specific topic of interest was a query on whether UN retirees were required to complete the Cyprus Government income tax return forms. Following a lengthy discussion, the President explained that each country had its own laws on this subject and summarised the debate by informing members about a Deloitte 2014 taxation guidance document outlining the Cyprus Government taxation laws and applicability which members were advised to read should anyone feel uncertain about how to comply with the law.

The Deputy President referred to rumours circulated in March 2014 with respect to the status quo on Pension Fund staff administration and investment of the assets of the Pension Fund which could have negatively impacted on UN retirees. However, all present were assured that the funds are invested with prudence following the four main criteria of safety, profitability, liquidity and convertibility, under volatile market conditions, and that the situation was closely monitored in New York by FAFICS, so much so there was no need for worry.

At the end of the meeting, a member of Personnel Section briefed former national staff members on the new medical insurance system which has been transferred from Henner, France to Cigna, Belgium.

The Executive Committee are delighted at the significant turnout for this Assembly, as it is important to keep all informed, preferably in person, of current affairs which are of specific interest to all AFICS members.

Visit to Famagusta

On 23 May, several members of AFICS together with friends and family, boarded a 55-seater bus and set off for a visit to the beautiful town of Famagusta under the guidance of Ms. Rita Severis of the CVAR (Cyprus Visual Arts Research) centre, an archaeologist with a remarkable in-depth knowledge of the area.

Organised by AFICS Cyprus Social Coordinator Fredy Galotopoulou, the tour began at 9.30 am. During the journey, Ms. Severis gave the visitors a brief account on the history of Famagusta during the period 1300 to 1500 AD. On arrival, a number of sites of cultural heritage were visited, including the Othello Tower, the Venetian Walls, the church of St. Peter and Paul, St. Nikolaos cathedral, and the Lusignan Palace.

Several journalists and representatives from Cyprus TV channels island-wide were present, together with members of the general public, many of whom took part in a question /answer session. With his frank approach to the Cyprus issue, Mr. Barth Eide managed very successfully to deliver his optimistic view on the negotiations currently taking place between the leaders of the two Cyprus communities.

The President of AFICS who was present throughout the evening had occasion to speak to Mr. Barth Eide and to Mr. Sergiy Illarionov (Ukraine), the Coordinator and Head of Office of the Special Adviser. This was a highly successful occasion, and AFICS was gratified since the donation approved for the CVAR at the last Assembly Meeting sponsored the event.
