## AMANA NEWS AND NOTES

### Where Do I Caucus?

The Iowa Caucus is Monday, Feb. 3 at 7 p.m. However, both parties are urging caucus goers to arrive before 7 p.m. to sign in and get set.

Arrive after 7 p.m. and you will not be able to participate in the caucus.

Both Republicans and Democrats will be caucusing Monday, Feb. 3. Both parties have set up locations for their caucus. Your caucus location may be different than your polling place.

To participate in the Iowa caucus you must be 18 years of age (or turning 18 before election day in November) and registered to vote in Iowa. Youth under voting age may attend as observers. If you aren't registered you may go to the Auditor's Office at the Iowa County Courthouse in Marengo or register online at [voterreadyiowa.org](http://voterreadyiowa.org).

You may register to vote or change your party affiliation at the caucus, however if you wish to do so please come early and bring photo identification. You may be asked to prove your place of residence (such as a utility bill with your name on it or a registered voter who can vouch that you live where you say you do).

How do I caucus? The Iowa caucus, according to the party websites is a "gathering" of neighbors during which the attendees elect precinct representatives to their county party convention and determine preferences for the national presidential election. Both parties may discuss platform topics and elect members to the county party central committee.

To learn more about how to caucus or to read the rules of the caucus go the party websites. It should be noted that both parties have made changes to their process as compared to previous years so as to streamline the process and provide a paper trail.

Both parties encourage all attendees to come early, bring paper and pencil so that you can take notes and/or fill out paperwork.

If I live in the Amana Colonies area where do I caucus?

### DEMOCRATS

If you live in Washington/ Hilton (West and South) Precinct go to the Iowa Valley High School lunchroom at 359 E. Hilton in Marengo.

If you live in Lenox Precinct (Homestead, Amana, East, Middle and High Amana) go to the Amana Elementary School, gym, 220th Trail, Middle Amana.

If you live in Honey Creek/ Marengo, Iowa Valley High School, Library room.

If you live in Marengo go to the Iowa Valley High School, gym.

If you live in Pilot, Troy, York go to the Mary Welsch Elementary School, 2383 Raider Dr. in Williamsburg.

If you live in Williamsburg go to Mary Welsch Elementary School.

### REPUBLICANS

If you live in Washington/ Hilton (West and South Amana) go to the Next Door Event Center beside Die Heimat in Homestead (the former Homestead Store.)

If you live in Lenox Precinct (Homestead, Amana, East, Middle and High) go to the Next Door Event Center in Homestead.

If you live in Pilot, Troy or York precincts go to the Williamsburg Recreation Center in Williamsburg.

If you live in the Honey Creek or the Marengo Precinct go to the Iowa Valley High School, 359 E. Hilton in Marengo. (no room is listed.)

If you live in Williamsburg to the Williamsburg Recreation Center.
