Specifications: Maximum frame - 48"H x 48"W. Weight limit: 40 lbs.

Framing: Wired and ready for hanging. No other types of hangers are allowed. All other work must be ready to install. TNPS reserves the right to install accepted works in a manner deemed necessary for exhibit or security reasons. Please attach the following information to the back of your work: name, title, medium, and price.

Submissions: Images of work may be submitted by email or regular mail. All images must be labeled clearly in whatever format chosen. The entry form may be scanned or the information emailed to nps@grics.net. Payment may be made online via PayPal to nps@grics.net. Send application, payment and materials to TNPS, 113 West First Street, Dixon, IL 61021.

Sales: Exhibited works will be considered for sale at the price indicated during the submission process. Works not for sale must be designated "NFS". We recommend a 25% donation to TNPS of the retail price for any artwork sold.

Publicity: TNPS reserves the right to photograph all exhibited work for publicity purposes.

Jurying: Only entries postmarked by indicated deadlines will be considered. All CDs and pictures will be retained until exhibition end.

Awards: Best of Show, 1st, 2nd, 3rd, and Honorable Mention (may be more than one).

Delivery & Return: Accepted work may be shipped or hand delivered to TNPS. Hours: Tuesday—Saturday, 10:00am—4:00pm. Artists are responsible for insuring their work in transit to and from TNPS. TNPS provides minimal insurance for work while on TNPS premises.
