

Alberta Bowhunters Association Raffle Rules – Raffle Lic # 499828
(2018 Black Bear Hunt with Alberta Prairie Outfitters)

Raffle # 499828 rules include the following:

- a) Raffle tickets will not be sold to a person under 18 years of age. Ticket purchasers must purchase tickets in Alberta and open only to Alberta residents.
- b) ABA will ensure adult ticket buyers do not write the name of a person under 18 years of age on the ticket
- c) ABA has no restrictions on ABA members, executive, raffle chairperson or their families, in buying tickets.
- d) There is no limit on number of tickets a person can purchase.
- e) 500 tickets will be available for \$20 each. Tickets will be numbered consecutively from 001 to 500.
- f) The draw will take place January 5, 2019 at Jim Bows Archery in Calgary, Alberta. A member of the ABA executive will be present when the draw is made - the person doing the draw will not have a ticket in the raffle. A draw drum will be used and a minimum of three agitations will be used.
- g) There is only one prize – the black bear hunt (for two). The Guide/outfitter for the hunt is Wes Schuett of Alberta Prairie Outfitters of Brooks, AB. Hunt value is \$12000 Cdn plus GST. There is no cash equivalent. The prize is non-transferable.
The raffle is for a trip for two – the winner can name the second person to go on the trip at anytime.
Each hunter will be allowed one black bear each.
The hunters can use any legal hunting equipment as outlined in the current Alberta Hunting Regulations.
Responsibility of raffle winner – transportation/accommodations to and from Fort McMurray, tips to guides/cook/helper, Alberta resident black bear license.
Exact hunt dates will be for one of the four weeks between May 11 and June 8, 2019 to be agreed on by raffle winner and outfitter. The weeks available are May 11-18, May 18-25, May 25-June 1, June 1-8.
To ensure the best opportunity to choose any one of the four weeks available, the raffle winner must notify the outfitter of their preferred week no later than 14 days after draw date/notification to draw winner. This is to facilitate and avoid conflict with other bookings in the outfitter's operation. Confirmation of the chosen week will be when the hunt contract is completed and received by the outfitter.
If after 14 days the winner has not yet chosen a week, the ABA in consultation with the outfitter will pick a week on behalf of the winner.
If, after the close of the outfitter's bear hunting season (June 8, 2019) and within 365 days of the draw date, the winner has not gone on the trip, the winner of the raffle will be awarded 20% of the total raffle value and that will be \$2000 CDN.
- h) Tickets will be available July 15 2018. Either at the ABA online store www.bowhunters.ca using a credit card or cash/cheque sales available from raffle chair person Brent Watson (brent@albertabowhunters.com - cell 780-978-1195. 10238-110 Ave., Grande Prairie, AB T8V 1S7). Sales will be time stamped once the transaction is completed online/cash or cheque in hand, to ensure first come first served.
ABA Members will have received notice in 2018 Summer edition of ABA Quarterly Newsletter
- i) If a ticket buyer requests to cancel their raffle ticket for a refund of the purchase price the ABA will refund the money either by crediting their credit card if it was a credit card purchase or by a cheque from the ABA for any cash sales or sales made by cheque.

i) The winner will be notified by a phone call, an email or a registered letter to the contact information they have supplied to the ABA.

k) Advertising of the raffle will take place through the ABA quarterly newsletter (Summer and Fall edition), the ABA Facebook page, ABA website, ABA mass email list, various social media forums. The winner will be announced through the same.

l) The ABA, its directors and/or officers, the ABA Raffle Chairperson are not liable or responsible for anything involving or associated with the hunting trip.
