The best approach to working with our elected representatives is for groups to appoint a committee of two to three members to conduct all interactions with the local and state legislators. It is vitally important (if you hope to build a long-term relationship and/or get a subsequent meeting) that all messaging be consistent and be delivered in a professional, non-confrontational manner. In addition, we want to always be factual and not just merely opinionated.

The following questions have been prepared, along with educational talking points, to accomplish **only five (5) very specific goals**. Specific initiative goals will be developed in subsequent meetings. The five goals are:

- 1) Educate - the congressional member, or staffer (using the talking points) to develop awareness
- 2) Generate - some “heat” by asking pointed questions like “what have you done or are you planning to do about”
- 3) Create - a desire to learn more and get him/her to start THINKING.
- 4) Develop - a sense of urgency to consider ACTING on specific issues
- 5) Document - the member’s viewpoint and future voting plan and get him/her on record.

Subsequent meetings should focus on remedial education to get their views in sync with ours, delivering supporting material on an on-going basis and developing partnership initiatives initially focused on issues that you both can agree on. Do not be quick to compromise. The more you educate – the more they will most likely begin to see it the same way you see it. If you are not seeing eye-to-eye, shelf it and come back to it later with a different approach and with more material supporting your view. A confused mind always says **NO**. Do not be discouraged. Several contacts or approaches may be needed to get agreement.

Do **NOT** attempt to engage in a religious debate or interject your personal bias. You are acting like a reporter – just collecting information and being friendly. Our collective bias will be included in the educational talking points already written. Stay focused and on point to achieve the highest level of success.

Unfortunately, you may only get about 15 minutes of time, so it is imperative to keep moving and try to get as many of the questions answered as possible without appearing to rush. Remember, part of the mission is to educate and get them to THINK, so you need to get the talking points out.

Your focus for the entire presentation should revolve around the illegal enforcement of Shariah’s seditious encroachment, its non-religious cultural demands and the suppression of Americans’ constitutionally protected rights (speech, religion, expression, conscience).

Blatant bashing of Muslims or Islam will not get you where you want to go. It may feel good, but you will ultimately lose the battle. As a politician representing all constituents,, they simply will not agree with you.

Meeting Conclusion

Be sure to thank the member for his/her time and let them know that you will be back in touch to “keep them in the loop” about specific initiatives that we are working on and to see how our group can help him/ her in their goals (like re-election). Try very hard to find AT LEAST one point that you agree on before leaving.

Questions for Legislators

Seditious Muslim Brotherhood Front Groups

The American Center for Security Policy, in their latest report titled, “Shariah: The Threat to America”, has listed 29 Muslim advocacy organizations (*including NAIT, ISNA and MSA*) as Muslim Brotherhood front groups (*as self-identified by the Muslim Brotherhood themselves in seized documents that led to 108 convictions in the Holy Land terror trial*). Those documents were referred to as the Explanatory Memorandum of the Muslim Brotherhood. The size of these groups is not insignificant and they are known to collectively have hundreds of thousands of members and sympathizers in America.

In addition to the groups mentioned above, the high-profile advocacy groups referred to as **CAIR**, **MPAC** and **IIT** (*International Institute of Islamic Thought*), although established after the drafting of the Explanatory Memorandum, can easily be mapped through network connections back to the Muslim Brotherhood. They also call for the U.S. Constitution to be replaced with Shariah law.

- 1) Why has Congress not taken measures to expose and dismantle these groups, since the group leaders have openly advocated for sedition by calling for replacing the Supreme Law of the Land (as stated in Article 6 of the U.S. Constitution) with Shariah Law?**
- 2) What is your position on what Congress should immediately do to eliminate the dangers posed by groups such as these that effectively advocate for the overthrow of the U.S. Government?**
- 3) Why have known members of these groups been allowed to infiltrate our government and intelligence units at the highest levels?**
- 4) What does congress plan to do about the U.S. Justice Department’s alleged suppression of the prosecution of the un-indicted co-conspirators exposed in the Holy Land Foundation trial?**
- 5) What can you, as a sitting member of Congress, do to affect change in this area?**
- 6) How can our group partner with you and help you accomplish the goal of exposing and dismantling these groups?**

Shariah Law

As you probably know, Shariah law is a complete way of life that is all-encompassing and includes strict adherence to political, legal, militaristic, lifestyle and religious mandates for every Muslim on earth to follow while forcing non-Muslims into subservient roles (*referred to as Dhimmi status*). In fact, as mentioned earlier, the Muslim Brotherhood creed demands the triumph of Shariah law globally as well as the establishment of the global caliphate.

Since by design, Shariah law does not allow for true Freedom of Speech, Expression, Religion, or of Conscience

- 1) What is your position on implementation of any form of Shariah law in America?**
- 2) How do you intend to vote on any bills introduced to stop the use of Shariah in our courts?**

As you may know, according to many Islamic scholars, the Quran, and therefore the Islamic religion, do not specifically require females to wear headscarves, burkas or veils; nor do they require specific times that prayers must be recited each day (although most Muslims will try to convince you otherwise). However, Muslims and Muslim advocacy groups are constantly demanding changes in the schools and workplaces to accommodate these ‘politically-based Shariah law rules’ that are only cultural in nature. And, even though they do not have a religious basis, they are constantly ruled on as the ‘suppression of the free practice of religion’ in our courts. Subsequently, businesses are forced to either submit to political Shariah law culture or are extorted for large sums in settlement arrangements. This has now become so common that it is being referred to as Legal Jihad.

- 3) Why has Congress not taken a stand or legal action to stop the courts from ruling in favor of these shams that are nothing more than a deliberate effort to force businesses to replace American culture with Islamic cultural norms under the guise of religion?**
- 4) Why is it that an immigrant group that makes up less than 1-2% of the entire population of America can suddenly be given special privileges by our courts to legally force the submission of our businesses, schools, government offices and financial institutions in submission to Shariah when there is in fact, no legal basis for such?**
- 5) Why has it become legally acceptable for a minority culture, many of which have ill will toward our country, to impose their will, against the will of the majority, while repeatedly infringing on the greater population’s protections afforded under the U.S. Constitution?**
- 6) What positions will you take now to restore full constitutional rights to Americans and American organizations?**

Shariah Courts

Recently, over 200 Islamic Imams held a conference in Houston to lay the groundwork on how to implement Shariah law and start Shariah courts in the U.S. Since it is well-documented that the radicalization elements in Islam are always strict Shariah law adherents

- 1) Why has Texas allowed the first Shariah court to be established in America?**
- 2) What can be done to reverse the decision to allow a Shariah court in Texas?**
- 3) What can you do, specifically, to affect this reversal?**

Education

I'm sure you are aware of the very deliberate effort to promote Islam in our schools as evidenced by the recent ruling by the Texas Board of Education on the extreme imbalance of the amount of text devoted to Islam as compared to that for other religions as well as the overwhelming amount of factually incorrect information on the history of Islam in those books.

- 1) What actions are you taking or are you prepared to take to stop the attempts to indoctrinate our school children with false and unbalanced information on Islam?**

Through the on-going efforts of the **Muslim Student Association** (*MSA, a known Muslim Brotherhood front organization*) on college campuses, our youth are being increasingly radicalized to act against the best interests of the United States and to support a new form of government. This appears to be the outright promotion of sedition.

- 1) What is being done to put a stop to these seditious actions?**
- 2) What actions have you taken that will aid in eliminating this threat?**

Global Shariah Initiatives

The Organization of Islamic Countries (OIC) has consistently insisted that the U.N. and the U.S. adopt laws that would effectively suppress free speech (*specifically, as it relates basically to any burning of Qurans, criticism of Islam or Mohammad, etc*) and calling for severe punishment of any violators. Our group is concerned that a future scenario could develop beginning with a severe provocation combined with an administration's willingness toward appeasement, that such a law could be agreed to under the guise of "global harmony". In fact, Pakistan has forcefully proposed this on several occasions.

- 1) What can be done to ensure that this scenario never happens in America?**
- 2) What could you do as a member of Congress to move a bill forward on this issue?**

Shariah-Compliant Finance

It is well known that Shariah-compliant finance was invented by the Muslim Brotherhood. In fact, the Muslim Brotherhood's spiritual leader Yousuf al-Qaradawi, says it was created to wage "jihad with money."

Potentially seditious financial products are now being marketed to large pension funds, insurance companies and corporations. Investment banks and other financial institutions have been hiring Muslim religious authorities to sit on corporate SCF advisory boards that directly influence the investment of billions of U.S. dollars.

Three of the eight causes that Shariah approves for philanthropy indirectly involve supporting jihad and a fourth explicitly does so. SCF amounts to terror support cloaked as a protected religious practice of tithing. In addition, SCF specifically forbids institutions from investing in anything that supports American defense but not Muslim defense. As these SCF products grow, financial institutions, as well as insurance and pension funds, could literally be held hostage with threats to withdraw billions overnight and collapse the banking system if the institution did not "play ball" (*like no Israel investments, no Jewish customers, etc*).

- 1) Why is the U.S. Government sanctioning SCF through the U.S. Treasury department and actually holding courses of how to implement Shariah finance for financial institutions? (*Islamic Finance Project at Harvard Law School. Dubbed "Islamic Finance 101"*)**
- 2) Why have the SEC, Federal Reserve Board and other gatekeepers of the financial system's security and integrity not recognized the dangers of SCF?**
- 3) What can you do to introduce legislation or at least conduct investigations into the potential security issues of SCF?**

Shariah-Compliant Mosques

According to Representative Peter King, it has been estimated that up to 80% of mosques in America have imams that condone a radical agenda. It has also been stated that most mosques built in America have been funded by foreign sources.

- 1) If a mosque is discovered to be promoting the establishment of Shariah law in the U.S. as a replacement for the U.S. Constitution or as a parallel system of government, what should Congress do about it?**
- 2) What are you doing specifically to help congress investigate and/or shut down mosques that promote radical agendas?**
- 3) What can our group do to help you in exposing or shutting down mosques with a seditious agenda?**

Religious Boundaries

Obviously, a group claiming human sacrifice as part of their rights under the freedom of religion clause would quickly be banned and never allowed to take root in America. However, Wikipedia defines human sacrifice as “the act of killing one or more human beings as part of a religious ritual”. As reported by the website Political Islam, a well respected organization, over 270 million people have been killed in the name of Islam and over 17,000 Islamic terror attacks have taken place just since 9-11 (*Obviously, this has not been done by just a “small minority of radical Muslims*). Since it is well documented that many devout Muslims with strict adherence to Shariah feel that is their absolute obligation to convert, subjugate or eliminate (kill) any non-Muslims (*infidels and kifars*)....

- 1) **In your opinion, how is allowing Shariah cultural norms to be gradually established until it grows to full intensity through coercion, subversion, legal and violent jihad and population explosion, any different than allowing a religion that claims the freedom to practice human sacrifice?**
- 2) **Why does our government allow politically-motivated actions that are seditious in nature, harmful to the identity of American culture and suppressive of constitutionally guaranteed freedoms to continue unabated and receive a legal shield simply because of their false and unsubstantiated claims of a ‘religious right’?**

Doctrine of Abrogation

Many people are unaware that the Quran is organized differently than most books and they become confused when trying to make sense of it. For instance, the Quran is not organized in a chronological timeline but instead is compiled in an order based on length of ‘chapters’. This has the effect of destroying the ability of the uninformed Westerner to distinguish between the importance of peaceful Quranic verses (*written in the early days in Mecca before Mohammad could get many followers*) and the later very violent Quranic verses (*written in the Medina era when he conducted a violent attack on average every seven weeks, killing or forcing submission of all who resisted Islam*).

According to the Doctrine of Abrogation, if there is a conflict in any of the Quranic verses, the verses written the latest will, in effect, supersede the older and more peaceful verses. Based on this, only 38% of the Quran (*43/114 Surahs/verses*) can be trusted as valid.

- 1) **We constantly hear that Islam is a religion of peace and regularly hear Muslim advocates quoting Quranic peaceful verses. Are you aware that nearly all of those verses are considered “null and void” by Muslims themselves and that the violent verses are what is primarily representative of the current Quran?**
- 2) **How can we partner with you to educate members of your staff as well as other members about important issues like the Doctrine of Abrogation?**

Additional Talking Points if Time Allows

1) Turkey's Prime Minister Erdogan has said, "**There is no moderate Islam. There is only Islam**". If you do not believe him, please read the Quran, Hadiths and Surahs. This is a global mission mandated for every Muslim in the entire world. It will not stop, ever. Jihad is an absolute requirement and a guaranteed ticket to Muslim heaven according to the Quran. America is the last country standing in the way of the global Caliphate. How hard do you think two billion Muslims will fight to make it 100%?

2) **Passing the proposed American Laws for American Courts is a good step but it will not protect America** in the end. The devout Shariah believer will absolutely overcome any and all "moderate Muslims" in America just as they have done in every country in the entire world wherever Islam has gotten a foothold. The reason is that the Islamic books mandate Jihad for ALL Muslims which includes the intolerance, killings and strict Shariah adherence. As the prominent moderate Muslim Dr. Zuhdi Jasser of the American Islamic Forum for Democracy stated in Congressman King's recent hearing, "**The moderates have no platform**". The entire doctrine is based on becoming exactly like Mohammed as he is considered by ALL Muslims as the perfect man. Important Selling Notes:

1) WIFM Principle- Don't forget the WIFM (spoken wiff 'em) Principle. Your representative will always be looking at your proposals with the "What's In It for Me" focus. If you do not figure that out **BEFORE** your meeting, your chances of success will be slim to none. Make sure that he/she absolutely understands what's in it for him/her before you leave that meeting.

2) AIDA Formula – to sell anything (product, service concept, etc) to anyone, you need to always remember that you must (in exact order) do the following:

A – Get their **Attention**,

I – Build their **Interest**,

D – Create the **Desire** to (own, buy, act, etc) and

A – Move them to **ACTION!**

Now, go get 'em!
