In consideration of my permission to attend the event as a spectator and/or a participant and to the use of the Iosco County Fairgrounds premises and facilities, I hereby forever release Hale Area Association, Iosco County Agricultural Society, and affiliate organizations, and their respective directors, officers, employees, volunteers, agents, contractors, representatives, and balloon or event sponsors (collectively "Releasees") from any and all actions, claims, or demands that I, my assignees, heirs, distributes, guardians, next of kin, spouse, children, and/or legal representatives now have, or may have in the future, for injury, death, disability, property damage, or property theft related to (i) my participation in or observation of the activities/the event, (ii) the negligence or other acts, whether directly connected to these activities or not, and however caused, by an Releasee, and/or (iii) the condition of the premises, whether or not I am then participating in or observing the event. I also agree that I, my assignees, heirs, distributes, guardians, next of kin, spouse, children, and/or legal representatives now have, or may have in the future will not make a claim against, sue, or attach the property of any Releasee in connection with any of the matters covered by the foregoing release. I further agree to indemnify and hold harmless all entities or person mentioned in this paragraph from any and all liabilities or claims made by other individuals or entities as a result of my actions during the event. I understand that any coverage needed will be through personal insurance. I understand that domestic animals are allowed on the premises but must be leashed and attended at all times. I further agree that any incident, damage to property, personal damage, personal injury, or any other circumstance involving my pet will be my personal and financial responsibility. Your homeowners policy showing your pet as insured against liability may be required. Bring copy of proof with you.
