*All employees shall be evaluated in accordance with section 2:92 Employee Evaluations of the Code of Ordinances of the Town of Arnaudville and given to the Board of Alderman with the recommendations of the Mayor and Chief of Police.
*New employees starting salary shall be recommended by the Mayor or Chief of Police for their respective departments and approved by the Board of Alderman.
