Call to Order and Roll Call – The meeting was called to order at 9:00 a.m. by Chairman Ellis. Open Meeting Statement – This meeting and all meetings of the Waupaca Chain O'Lakes District Board are open to the public. Proper notice has been posted and given to the press in accordance with Wisconsin Statutes so that citizens may be aware of the date, time, place, and agenda of this meeting.

Review and Approve Agenda – A motion to approve the agenda was made by C. Murphy, seconded by Silloway and unanimously approved by the Board.

Review and Approve Minutes of Previous Board Meeting, 4/28/22 – A motion to approve the April minutes was made by C. Murphy, seconded by Silloway and unanimously approved by the Board.

Treasurer's Report/Bills – Denow reported a cash balance of \$78.288.94. The audit report will be completed in August.

Treatment and Sampling Report – Denow explained in detail about ProcellaCor, a synthetic liquid that affects the growth process of invasive plants, and the steps involved in post-treatment sampling in the Chain over a five-day period. The potential next treatment for areas done this year would not be required for three years. This is the second year ProcellaCor has been used in selected areas of the Chain.

Chairman's Report – Ellis announced that Cathy Raynor will be retiring from the Board in June after serving as Secretary for nine years. Raynor did an excellent job and definitely will be missed by the Board.
