

City of New Munich
City Council Minutes

June 5th, 2017

The City Council of the City of New Munich met in regular session at 6:35 p.m., in the City Hall. Jim Poepping, Shawn Duevel, Pat Nathe and Ron Doll were present, Dan Krueger was absent.

On a motion by Ron Doll, seconded by Pat Nathe and carried the minutes from May 1st. 2017 were approved.

Fire Chief, Allen Fiedler was present to inform the Council of three medical calls and one fire call (carbon monoxide alarm) last month. Allen had asked the Council about getting an internet connection in the City Hall. They are looking into "I am responding" pagers which needs an internet connection. There was a water leak from the hot water heater in the City Hall. Mayor Jim will contact a plumber to check it out. Allen submitted some bills that need to be paid, Granite Electronics \$483.00, Fire Safety USA \$4294.00, Chiefs Meeting \$20.00 and Melrose CentraCare \$188.00.

Jaycee member, Sandy Zierden was present to get approval on a one day gambling resolution. On a motion by Pat Nathe, seconded by Ron Doll and carried Resolution 6-17-A was approved. She also submitted a check from the New Munich Jaycee Bar Bingo account of \$1668.91 which will go towards the purchase of Christmas Lights the Lion's purchased.

On a motion by Pat Nathe, seconded by Ron Doll and carried the following building permit was approved, Jesse Job.

On a motion by Pat Nathe, seconded by Ron Doll and carried the following building permit was approved pending City Attorney approval, Josh Horstmann. The City is checking with the City Attorney about the pier foundation and what the set backs are because of the unique shaped lot.

It was brought to the City's attention that people are spearing at the creek north of town and them just leaving the fish lay, possible looking into putting a sign up.

There were 16 residents plus a Stearns County Officer present to discuss the issue about renters in 141 7th Ave. They would like to know what we as a city can do going forward. The City will contact the City Attorney for any information or Ordinances we can pass to improve the situation.

Ray Painter was present and informed the Council that in Ordinance 2, section I; it states no shooting or discharging of firearm .This ordinance is written in cursive and is not very

legible. The City Clerk will contact the City Attorney to see if these ordinances written in cursive needs to be amended or rewritten.

On a motion by Pat Nathe, seconded by Shawn Duevel and carried the City will purchase a receptacle for the generator.

Pat Schwieters and Sandy Zierden requested copies of Ordinance 90 which the City Clerk will print for them.

On a motion by Ron Doll, seconded by Pat Nathe and carried the Local Government Aid will go into the general fund.

On a motion by Ron Doll, seconded by Shawn Duevel and carried Resolution 6-17-B (Supports the hazard mitigation planning effort and wishes to adopt the Stearns County All-Hazard Mitigation Plan) was approved.

On a motion by Pat Nathe, seconded by Ron Doll, carried and approved the City will purchase digital Badger meters from Metering and Technology Solutions.

On a motion by Ron Doll, seconded by Shawn Duevel and carried a one-day on sale liquor license was approved for the Immaculate Conception Parish for Munichfest.

Homeowners rental enforcement tabled till next regular schedule meeting.
