General Meeting Minutes

April 8, 2021

Pledge: 7:00 PM

Board Attendees: Tony McClure, Don Spearing, Cal Roberts, Daisy Spearing, Dan Charles & Mike Wyckoff.

A moment of silence took place in honor of past club president Harry Gromo.

Secretary's Report: Daisy Spearing read the minutes from the March 11, 2021 meeting and a motion was passed approving it.

Bylaw Changes: Daisy Spearing completed the second reading of the bylaw change submitted by the Board of Directors. This change will update Article 10 Sections 2 and 3 involving the process of amending the Bylaws. A motion was made and passed approving this bylaw change.

Bylaw Changes: Daisy Spearing completed the first reading of the bylaw change submitted by the Board of Directors. This change includes adding wording for the process of rejecting an application, updating the Board of Directors term to 2 years and adding Article 11-Dissolution of the Club.

Treasurer's Report: Cal Roberts read the treasurer's report and explained that we had switched our accounts from Huntington Bank to Clearview FCU.
