- Jim said we will look for uneven areas

Richard Kohles – asked for details about the budget

Jim reviewed

- How are we doing on delinquencies
 - The first quarter the delinquencies are the highest for the year
 - o Last report, the delinquencies are low compared to historically
 - o It was agreed we are in good financial shape for an association

Greg- Tennis nets are up on the upper courts

- Tennis and pickleball players welcome
- Have worked on the cracks in the court but are not sure how it will be addressed in the long term.
 - Upper court has the cracks.

Matthew Hall – Neighbor asked about some dead trees in the common areas

- Forest Management budget includes an amount for tree removal
 - o Board will discuss getting a forester in for a day or two to clean up dead trees
 - Runs about \$1000 a day. Should be able to work it all in about 2 days
 - Immediate hazards will be addressed on an individual basis.
