KEEGANS GLEN ANNUAL BBQ Saturday, July 3

This year Keegans Glen (KG) will celebrate Independence Day with a barbecue on Saturday, July 3. The pool will NOT be open. KG residents in good standing are invited to pre-register. Pre-registration is mandatory. Plates will not be available to those who do not pre-register. The registration period is Friday, June 18 through Friday, July 2. We will have plates for the first 200 residents.

Residents will enter through the pool gate at or during their assigned timeframe. After giving the volunteers your name & presenting either (1) a KG ID card from 2019 or later or (2) a recent utility bill indicating your name and KG address, the volunteer will confirm your name & the number in your party (to match the reservation). They will give each party member a plate ticket. From there, residents proceed to the BBQ plate collection area and then leave through the exit gate.

The procedure to participate for KG residents in good standing (no outstanding dues or fees) is as follows:

Starting Friday, June 18, residents can call the Clubhouse - 281-561-6215. If leaving a message, include your name; property address, return phone number & number of family members requesting plates. It is vital that we have your phone number (or a phone number where we can leave a message) so we can confirm your registration. We will audit the information to confirm standing & that the number of family members match the number in our records. If there are any discrepancies, we will contact you.

Whether verbal or via message, we will assign you a BBQ plate pick-up time at registration. The pick-up time confirms your reservation. If you have not received your assigned pick-up time, your reservation is NOT confirmed.

On Saturday, July 3, the pick-up time frame will be strictly enforced. **DO NOT** plan to arrive early or late. We cannot accept stragglers. As in prior years, all those requesting BBQ plates must pick up their plates as a group.

We love our volunteers. To volunteer, please call the clubhouse at any time after receiving this newsletter & let them know you want to volunteer.

July 3rd BBQ (Cont'd.)

- To volunteer we will need your name, address and phone number. We will advise the time for volunteers to arrive the clubhouse on July 3.
- The pool will not be open. However, to receive your plate(s) you will enter through the pool gate.
- We will have on-site security as in prior years.
- Following CDC guidelines, there will be a reservation-period limit. Register early.
- For the safety of our more vulnerable residents, we will social distance, and we are asking that you properly wear your mask.
- **When pre-registering, don't forget to leave a phone number so we can confirm your reservation.**

HURRICANE SEASON

Hurricane season runs from June 1st to November 30th. The Harris County Office of Homeland Security & Emergency Management Department has released information concerning hurricane season.

The agency urges everyone to currently be prepared during the season. It is advisable to have on hand during this time an emergency supply kit that includes the following items:

- ✓ **NOAA weather radio and batteries**
- ✓ **Flashlight and batteries**
- ✓ **Extra eye glasses**
- ✓ **Bottled water**
- ✓ **Non-perishable food**
- ✓ **Clothing**
- ✓ **Bedding**
- ✓ **Medications**
- ✓ **Copies of prescriptions**
- ✓ **Special products for babies, elderly, and medically fragile family members**
- ✓ **Cash and credit cards**
- ✓ **Photo ID, important documents and records**

If you live in an area threatened by storm surge – an Evacuation Zone – discuss evacuation plans with your family. Check with city or county officials to find out if your home is in an evacuation zone.

Make sure your home insurance policy is current. If you live in an area prone to flooding, tornadoes, or hurricanes, your standard homeowner's policy may require additional policies to cover flooding and wind damage. Make a checklist of preparations to be made before an evacuation and go over it with your family. Review it again when a storm is in the Gulf of Mexico. If you plan to stay in a hotel or motel, make reservations and confirm your reservations before you leave. If you plan to stay in a shelter, bring what you need to be comfortable, including bedding and toys for kids.

Prepare an emergency kit for your pets and a plan for how to care for them when you are on the road and in a shelter or motel. Do not leave your pets behind! Finally, stay informed by the news media. Local officials will provide information about current conditions, evacuations and re-entry.

HEAVY TRASH PICK-UP SCHEDULE

Heavy Trash Pick Up and Tree Waste Pick up is every first Monday of the month unless it is a holiday. The type of waste pick up varies depending on which month of the year it is. For the remaining months of 2021, the pick-up schedule is as follows;

Tree Waste: Monday, July 5, Tuesday, September 7 (no pickup on Labor Day, Monday, September 6), and Monday, November 1st.

Junk Waste Pick Up dates for the remainder of the year are as follows:
Monday, August 2, Monday, October 4, and Monday, December 6th.

If you are ever unclear as to what you may place at the curb during certain months, please contact the City of Houston by dialing 311 or 713-837-0311 to inquire. Fines are issued by the City of Houston to Residents that place heavy trash/tree waste in public view any earlier than the Friday before pickup is scheduled.

KG SECURITY CORNER

There has been an increase in fraud as it relates to filing for unemployment claims. Please enter a fraud alert with one of the listed credit reporting agencies, which will alert you if someone uses your information without your knowledge. Your fraud alert may be entered by accessing one of the following websites via internet: www.equifax.com, www.experian.com or www.transunion.com.

Additionally, there has been an increase in thefts across the City of Houston and Harris County mostly due to COVID and people being out of work. Listed below are some helpful tips you can utilize to hopefully prevent criminals from entering Keegans Glen. Remember to always remove all valuables from your vehicle and lying around your property.

1. Remove all valuables from your car before exiting.
2. Do not place a cover over anything left in your car. Criminals will suspect it is valuable.
3. Lock. Lock. Lock all doors.
4. Loose change left in your car is also an invitation to a criminal.
5. DO NOT store or leave tools inside your vehicle or in view on the outside of your property.

Call 911 TO REPORT ANY SUSPICIOUS ACTIVITY.

DEED RESTRICTIONS

The deed restrictions are enforced in KGHOA. It is not only essential but also a requirement throughout the neighborhood that each property owner comply with the deed restrictions and rules of the subdivision. If you do not have a copy of the deed restrictions for your property section, please access the Keegans Glen HOA website online at: www.keegansglenhoa.com. Click on the "Documents" Tab to open the listed sections of deed restrictions available for your review. You will have the ability to download them should you desire to have a hard copy for your records. You may contact the office with questions you may have regarding the deed or should you require further assistance in obtaining the deed restrictions for your property.

SOME COMMON DEED RESTRICTIONS

Grass/weeds must be kept mowed. Lawn and flower beds must present a neat appearance. Garbage, trash, piles of weeds or grass may not be allowed to accumulate. Lots may not be used for storage of equipment or materials except for normal residential requirements. Boats, campers, trailers, large commercial trucks over ¾ ton, and permanently parked or inoperable vehicles may not be kept on the street or in the driveway. Use of window air conditioners is prohibited or restricted depending on which section of KG in which you reside. All lots are for single family residences only. Businesses and other activities not related to single family residential purposes are prohibited. Burning of trash is prohibited. Dogs, cats or other common household pets are allowed as long as they are not kept, bred or maintained for commercial purposes. Dogs MUST be kept on a leash when out of the house or fenced back yard. Chain link fences are prohibited. Walls, fences and hedges along the side and rear line may not exceed six (6) feet in height in some areas. Please refer to your section of the deed restrictions for further clarification. All home improvements such as roofing materials, painting, installation of siding, fences, storages, additions, etc. require specific approval of the ACC form before improvements are started/made. Please contact the office at 281-561-6215 Mon – Fri 10 a.m. – 2 p.m. to request delivery of an ACC form to you via email, fax or U.S. Mail.
