PUBLIC COMMENT ON AGENDA ITEMS

Elfriede Tillman- At the Sept 7th meeting she questioned why the UV highway chipper was being hauled to Poughkeepsie. She noticed it is on tonight's agenda but does not understand what took 3 months to get it repaired. Councilman Welsh stated it is a Highway Chipper and to follow up with the Superintendent to find out further details. Supervisor Tompkins noted that it appears to be an electrical problem perhaps from being left out.

REPORTS OF SUPERVISOR & COUNCIL

Councilman Frazier said he will be meeting with George Kolb about the signage law. Councilwoman Kelley wanted to thank all that came to the Ethics training, as many residents and all Ethics members were in attendance. She provided a sign-in sheet so that we may keep track of the training. She also spoke further on the timeclock system and why the record is being overridden due to documentation purposes.

MOTION TO ACCEPT TIMECLOCK CHANGE FORM

Councilwoman Kelley made a motion to accept a document that allows for better record keeping in the event the timeclock needs to be over-ridden which was a recommendation from the Office of the State Comptroller. This was seconded by Supervisor Tompkins and all were unanimously in favor.

MOTION TO CANCEL DECEMBER 21, 2017 MEETING

Councilwoman Kelley asked how the Board felt about canceling the December 21st meeting as there was little to discuss. Councilwoman Kelley made a motion to cancel the December 21st 2017 Town Board meeting which was seconded by Councilman Welsh and were unanimously in favor.

NOW THEREFORE BE IT RESOLVED, that the Town Board of the Town of Union Vale hereby accepts the resignation of Thomas Tierney effective November 29, 2017; and

BE IT FURTHER RESOLVED that the Town Board of the Town of Union Vale hereby authorizes the hiring of Adam Pratt, on a temporary interim basis to the position of park employee at an hourly rate of \$17.00 for a period not to exceed 80 hours per pay period, commencing December 1, 2017.

Supervisor Tompkins felt that this should be advertised in the newspaper and wants this to be checked with the Duchess County. She feels this is not fair and should be duly advertised. Councilman McMorris said he agrees that it should be advertised but also need to fill the position. Parks Manager said this was to fulfill the needs of the upcoming season he has no preference on

PUBLIC COMMENTS ON NON AGENDA ITEMS

Glen Morrison lives on Bloomer Road has lived there for 29 years. He noted that the amount of holiday light traffic has increased and the traffic jams that have occurred along with the trash, and ruts caused by the heavy flow. He appreciates all the family's that enjoy it but is curious to see what power the Board has over this and hopes there could be a better way to manage the hours of the event perhaps by reduction. He also is wondering about re-routing the traffic thought West Clove as another solution. Supervisor Tompkins said there is not much the Town Board can do about this however she suggested perhaps speaking with the homeowner to suggest this idea as Mr. Gay is a very approachable and willing listen to reason. Supervisor Tompkins suggested perhaps the Fire Department but Councilman Welsh said it is more of a decision for Mr. Gay or Town Constables. There was further discussion on why traffic was routed the way it was. Councilman McMorris said he would no longer be advertising for the event which should reduce some traffic. Supervisor Tompkins also brought up the monetary side of the Town paying for Constables hours. Councilman McMorris noted the extra hours were minimal estimating an additional \$1,000 and only go when in need of a public safety concern. In the end it was again suggested to speak with Mr. Gay to come to a solution. Councilman Welsh suggested asking the Constables to take a tougher stance of littering as the fines are \$500.

Councilman Welsh noted that this will be the Supervisors final meeting said he congratulated Supervisor Tompkins on doing everything she could and all the efforts she made through the years. Supervisor thanked everyone and said she enjoyed working with everyone and thought that it was a great Town Board to work with.
