Not only is the month of August a time of planning and getting ready for school it is also a time for planning or getting ready for another year of Catholic Daughters. I believe most courts take the summer months off and now it is time to think about getting ready for the year ahead and for that first meeting of the year. A big THANK YOU to those of you that said YES to being an officer whether you took the same office, a new office, or if you are a NEW officer. In visiting with some of the newly elected officers there is always some apprehension that they will not do a good enough job. Just do your best and do not be afraid to ask questions and/or ask for help. Remember officers are there to guide and help, they are not there to do all the work. They are there to do the paperwork and to get the messages from State and National to all the members. The members of the Court still need to help with the running of the Court as well. The duties of an officer should only take up about one hour of your time during the month. Obviously, this can be more or less time depending on what is going on in the month, but the point is duties need to be delegated. When committees are assigned let them do their job – as an officer or a court member do not try to micromanage them.

Please be considerate of your chaplains, ask them if they will be able to make it to your meetings and don't expect them to make it to all your meetings. If you would like them to speak or do something special at your meeting(s), be sure to ask them – they may not know what you expect or want from them. Communication can go a long way.

As you plan your year remember that you do not have to do everything you have always done if you feel it is too much to undertake. Please do not stress yourselves out by trying to do too much. On the other note don't be afraid to try something new – sometimes change is exactly what we need. Regents, if you are a "new regent" or really any officer, do not worry about doing things exactly the way the past regent or officer did the "job", there is more than one correct way to get the job done. Please though, do not leave out the Spirituality spoke of the Circle of Love; this should be a priority.

Jesus said to his disciples:

"I have come to set the earth on fire, and how I wish it were already blazing! There is a baptism with which I must be baptized, and how great is my anguish until it is accomplished!"

Luke 12:49-50

What are you passionate about? What stirs up the fire within you?

In this Gospel passage we are given a sense of the passion that is burning within the heart of Jesus: This fiery Jesus might startle us, as he proclaims his desire that the world be aflame with the same fire that consumed him.

The passages from Luke's Gospel that we are hearing in this span of Ordinary Time are inviting us to reflect on what it means to live our faith, putting into practice what we profess.

When looked at from the perspective of discipleship, we recognize that what Jesus is asking us to consider is the prophetic stance that is part of discipleship. That prophetic stance can put us at odds with those who are opposed to the truth. This was certainly true for Jesus, as well.

In 2016, Pope Francis spoke of this refining fire, when he reflected:

"The *fire* that Jesus speaks of is the fire of the Holy Spirit, the presence living and working in us from the day of our Baptism. It — **the fire** — is a creative force that purifies and renews, that burns all human misery, all selfishness, all sin, which transforms us from within, regenerates us and makes us able to love. Jesus wants the Holy Spirit to blaze like fire in our heart, for it is only from the heart that the fire of divine love can spread and advance the Kingdom of God. It does not come from the head, it comes from the heart. This is why Jesus wants fire to enter our heart. If we open ourselves completely to the action of this fire which is the Holy Spirit, He will give us the boldness and the fervor to proclaim to everyone Jesus and his consoling message of mercy and salva-

tion, navigating on the open sea, without fear."

And it is here that we discover a sort of two-fold examination of conscience within this Gospel.

First, do you ignore or try to silent those prophets who are calling for change — change within ourselves, and our communities?

Second, are you willing to live out your call to be a prophet yourself?

As we continue our journey through Ordinary Time, reflecting on the demands of our discipleship and what it means to truly live the faith we profess, recall the words of Saint Catherine of Siena,

"Be who God meant you to be and you will set the world on fire."

In July most of your State Board traveled to Puerto Rico for the National CDA convention. It is a privilege to spend time together, pray together and meet Catholic daughters across the USA. Voting on things that will affect who we are and what we do for the future of CDA. One of the interesting facts I wanted to share with you is North Dakota ranked 10th of 40 total states in the amount given to the National Projects and Charities. You can all pat yourselves on the back! This is an awesome accomplishment and shows what we are made of and our values! What are the National Projects and Charities? We have 5 projects that Courts are asked to give \$20 or more to each year.

<u>Habitat for Humanity</u>: Helps families get into safe and affordable housing

Holy Cross Family Ministries: Promotes prayer and spiritual being of families in 16 countries "The Family that prays together Stays Together"

<u>Laboure Society</u>: Mission is to rescue Catholic Religious Vocations from the barrier of student loan debt.

National Center on Sexual Exploitation: (formerly Morality in Media) Fighting to expose all forms of sexual exploitation.

SOAR.: Support Our Aging Religious

Then we have 10 Charities that you can support with \$10 each or choose which ones your Court feels strongly in supporting.

Apostle of the Sea: Provides spiritual, physical and psychological support to seamen at port locations in the United States.

<u>Catholic Extension</u>: Supports and strengthens poor Catholic Mission Dioceses across the US.

<u>Catholic Relief Services</u>: Aids the people in the poorest parts of the world.

Blessings to my Sisters in Christ!!

I hope you are having a wonderful summer, enjoying the warm weather, and having time for rest and relaxation!!

The raffle was very successful this year, so we as a State Board chose to give the courts another break. We decided and voted to waive the state dues for the time of October 1, 2021 through March 31, 2022. Your courts will receive a billing verifying what your state dues would have been and that they were waived.

Your next state dues will be coming out in November covering membership from April 1, 2022 through September 30, 2022. Please be sure to check over your rosters to make sure your membership is correct. You will want to make sure to get any membership additions or deletions sent to the National Office before September 30, and while you are sending the changes to the National Office, please send a copy of the changes to me too. The National Office sends out dues for membership by what your court is showing for membership at their office on September 30 and March 31 every year. When you have changes to your membership, you want to make sure you get them sent to the National Office and to me before those dates, otherwise you end up paying dues for ladies who have either resigned or have died. Also, I send out dues by what the National Office sends me for membership, so it is very important to get membership changes submitted to the National Office. You send them to me to keep the state records up to date, that is why you need to send the changes to both National and State. If you email the changes to the National Office, you can CC (Carbon Copy) me at sjuddcda@gmail.com and that way you only have to send I email. If you snail mail them, then you need to send them to both the National office and to me. Please let me know if you have any questions about this.

I also want you to know that at the National Convention in Puerto Rico this summer the National dues were raised from \$15 per member, per year to \$18 per member, per year. Memberships are down, and they need to be able to take care of their expenses. The dues will still be billed out twice a year at \$9 per member in April and in October every year. State dues are staying at \$5 per member, per year, billed at \$2.50 per member in May and November. So again, I want to emphasize how important it is to keep memberships up to date with both the National Office and the State.

Before I end this, I want to encourage each and every one of you to invite a friend to a meeting or special event that your court is having and work to get more like-minded women involved in Catholic Daughters. Share

We strive to be saintly women, but to become a saint may be beyond our imaginings. There is information from the USCCB at https://www.usccb.org/prayer-andworship/prayers-and-devotions/saints/american-saintsand-blesseds about eleven Americans who have been canonized as saints and four who have been beatified. These include St. Elizabeth Ann Seton, St. John Neumann, St. Marianne Cope, St. Katharine Drexel, St. Damien de Veuster of Molokai, Saint Junípero Serra, St. Kateri Tekakwitha, St. Mother Théodore Guérin, St. Isaac Jogues, St. Frances Xavier Cabrini, St. Rose Philippine Duchesne, Blessed Francis Xavier Seelos, Blessed Sister Miriam Teresa, Blessed Father Stanley Rother, and Blessed Father Solanus Casey. They are all wonderful examples for us, but many were alive over 100 years ago. Of those listed, the most recent are St. Katherine Drexel (died in 1955; canonized in 2000) and Blessed Father Stanley Rother (died in 1981; beatified in 2017). A recent addition to the list of Blesseds is Blessed Father Michael McGivney (died in 1890; beatified in 2020), who founded the Knights of Columbus.

You may have heard that Bishop David Kagan has announced the opening of the diocesan investigation which could lead to the beatification and canonization of Michelle Christine Duppong. Michelle was raised in Haymarsh, North Dakota. She graduated from NDSU before working as a FOCUS missionary. After her time with FOCUS, she worked as the Director of Adult Faith Formation for the Diocese of Bismarck. Unfortunately, she was diagnosed with cancer in December 2014 and died on December 25, 2015, at the age of 31. What struck me was her dedication to bringing others to Christ, her acceptance of God's Will, and her intention to offer her suffering for others. She was described as "praying at all times." If she would be canonized as a saint, she would be the first saint from North Dakota. Even if she is not beatified and canonized, Michelle Duppong is a wonderful example of a contemporary saintly American woman, faithful to Jesus Christ.
