John made a motion to adjourn meeting from April 4, 2017. Second by Ed. All in favor.

Ed called the meeting to order at 4:00 pm.

Holly presented four Timber Yield Tax warrants. John made motion to authorize collection of \$1,471.47 from Harvey Hill. Second by Ed. All in favor.

John made a motion to authorize collection of yield tax of \$2,736.91 from Jeremy Turner and Laura French. Second by Ed. All in favor.

John made a motion to approve Yield Tax for and Gertsch-Schlauch for \$1,228.99. second by Ed. All in favor.

John made a motion to authorize collection of Timber Yield tax for \$1,002.91 from Wilbur Cox Jr. Second by Ed. All in favor.

John made a motion to approve a vacation request for Rosemary for July 10, 24 and August 14, 28. Second by Ed. All in favor.

Rosemary asked if she should still collect a fee for pistol permits. Ed made a motion to continue collecting fees for pistol permits. Second by John. All in favor.

The Selectmen read a letter from Joe Warner regarding the Fire Department.

John made a motion to approve an Elderly & Disabled Tax Deferral. Second by Ed. All in favor.

John made a motion to have Chairman sign the Septage Agreement with Claremont for 2017. Second by Ed. All in favor.

John made a motion to have Chairman sign the Agreement with Avitar to upload PDF's of the tax cards so that CAI's online mapping can access them. It will be a one-time cost of \$550.00. Second by Ed. All in favor.

John made a motion to accept \$100.00 for the State of NH on excavation for Kalervo Heino's Intent to Excavate. Second by Ed. All in favor.

Ted Lewit discussed various Parks & Rec projects and repairs.

Bruce Adams inquired about the open Highway position as well as the Volunteer Fire Department openings. The Board stated that they would be discussing next week.

Anthony Zullo asked if he needed a permit for maintaining Reed Road off of Cold Pond Road which he has been maintaining for many years. The Board suggested that he fill out a Road Release & Agreement and that he should keep Harold informed on what work he is doing.

Linda Callum stated that the Historical Society would like to start videotaping some of the people in town and they have chosen a camcorder and would like the Selectmen to consider paying half. The cost is 447.99. She also said that they would like to put up signs at old mill locations in town.

John made a motion to have rabies clinic on May 6th at the Town Office from 11-1. Second by Ed. All in favor.

John made a motion to sign two pistol permits. Second by Ed. All in favor.

The Board reviewed the resumes for Fire Department and Highway. Tracy will try to set up interviews for Thursday at 4:00.
