The Jewell County Commissioners, Steve Greene and Mark Fleming met on Monday, August 8, 2016 at 8:00 a.m. as the Board of County Canvassers, to canvass the ballots from the August 2, 2016 Primary Election. The Commissioners appointed Houston Becker to serve on the Board of Canvassers in the absence of Dwight S. Frost. Carla J. Waugh, Jewell County Clerk/Election Officer was also present.

The ballots for the Primary Election were canvassed with 6 provisional ballots reviewed and 4 deemed valid and counted.

The canvassing was completed and the board adjourned at 9:10 a.m.

COMMISSIONERS PROCEEDINGS

The Jewell County Commissioners met August 8, 2016 at 9:10 a.m. with Commissioners, Steve Greene and Mark Fleming present. Carla J. Waugh, County Clerk was also present.

The minutes of the August 1, 2016 County Commissioners meeting were approved.

Steve Melby discussed funeral expense assistance. He was provided with the affidavit that needs to be completed by a family member.

Don Jacobs, Sheriff, had the quote from Buffalo Creek Firearms for trading in guns. The Sheriff Dispatchers had training last week for the Next Gen 911 system. Don set August 24th as the date for another test of the security system.

Wanda Backstrom, Community Corrections & JJA Director, reviewed the yearend report for the FY2016 Adult Community Correction Program. Wanda Backstrom introduced newly hired employee, Jennifer Warkentin, Coordinator for Juvenile Intake. Steve Greene moved the proper officers sign the FY2016 yearend report for the Adult Community Correction Program. Motion passed.

Steve Melby returned the affidavit for request of funeral expense assistance.

Joel Elkins, General Superintendent, reported on road & bridge maintenance. The Commissioners reported road concerns. Joel had bids for truck and motor grader tires:

Mark Fleming moved to accept the tire bids of \$25,361.63 from Lloyd's Sinclair. Steve Greene seconded the motion. Motion passed.

The Commissioners reviewed the request for funeral expense assistance. Steve Greene moved to deny the request from James Garst for funeral expense assistance since the deceased was not a resident of Jewell County. Mark Fleming seconded the motion. Motion passed.

Mark Fleming moved to pass Resolution 16-05 repealing Resolution 13-10 that was adopted December 9, 2013 prohibiting Jewell County Employees from the open or concealed carry of weapons in any county facility, property, vehicle or equipment. Steve Greene seconded the motion. Motion passed.

The meeting was adjourned at 12:02 p.m.
